

Selectboard bumps Getty; makes Hayward interim Planning Dir

At its meeting on 2/11, the Fairhaven Selectboard again bumped the issue of Fairhaven Getty's license without a vote, despite resistance by Selectboard chair Daniel Freitas. The board was short-handed, with two of three members present, because Charles K. Murphy, Sr. was absent due to the death of his mother last week.

"I'm ready to roll on it," said Mr. Freitas, reiterating his contention that if the owners were going to comply the would have already. If not, he said, they should simply lose their license to operate.

At issue is the gas station, which also has a license to sell used cars, routinely having too many cars on the lot, allegedly parking cars on the street, and blocking the driveways and fire lane. The business has been in front of the board numerous times over the years, with the latest complains dragging on for months as the issue keeps getting continued for a variety of reasons.

At the last meeting, the business had asked for an extension to 2/26, but the board only granted it until 2/11, because it was unclear why they were asking for the extension.

Selectboard member Bob Espindola said he did not like not knowing the reason. He said, though, that being out of the country was "legit." It was unclear if the owner or his attorney was the one out of the country.

Mr. Freitas said he would use his discretion as chairperson not to put it back on the agenda. He said if the business complies by the next meeting on 2/27, then they comply. If not then they will not have a license, although that route does require a

vote of the board.

"It's gone on for far too long," said Mr. Freitas.

Mr. Espindola seemed to question how that would all work if it does not get on the agenda.

Town Administrator Mark Rees said he would make sure that the Getty complies with staff recommendations by making the physical improvements to the site.

"They've just got to agree," said Mr. Freitas.

Mr. Rees agreed, saying, "This is not a negotiation."

The board made the deadline for

compliance 2/20, to give allow a few days before the next meeting.

Louis Baptiste, who owns RRR Auto, which is across the street from the Getty, and whose complaints about his rival have reached legendary status, told the board that the owner of the Getty was simply showing disrespect for the town, the board and the bylaws.

"If that was my license, I'd have to be on my deathbed not to be here," said Mr. Baptiste as he walked out the door.

Because Mr. Murphy was absent, the board did not vote on the wage classification plan amendment that would have added the water and

sewer superintendents to the plan. The board continued it from the last meeting after some disagreement with Board of Public Works members. The item was removed from the agenda at the beginning of the meeting.

The board also held a public hearing on the Community Development Block Grant project for Hedge Street.

The project is the second phase of a three-phase project. Phase one improved Hedge Street from Cherry Street to Main; this year will be Cherry Street to the Acushnet River; next year, phase 3, will be Main Street to Adams Street.

No members of the public attended.

The board also voted to approve the appointment of long time Planning Board member Wayne Hayward as interim Planning Director.

Gloria MacPherson quit abruptly after about eight months on the job, saying she was going back to school.

The board voted to exempt Mr. Hayward from the ethics clause because he will also be a paid employee and also an elected official on the board that interacts with the Planning Director most often. He will serve until a new PD is hired.

The board also heard from Conservation Agent and Sustainability Coordinator Whitney McClees, who gave the board details on the project proposal the town will submit detailing how the \$174,535 Green Community grant will be spent.

The town has four specific projects outlined.

The first is LED lighting for the Senior Center and Recreation Center. The project will include smart

controls. The reduced energy consumption is estimated to save the town \$14,562 annually. The project will use \$76,376 of the grant money.

The second project will install an energy management system at the high school to "refine and tighten building temperature controls." The new system will allow for remote control of the system. Estimated savings are \$10,946 per year in gas and electric savings. The project will use \$48,600 of the grant money.

Project three will install an energy management system at Hastings Middle School. As with the high school, the new system will allow for remote control of the equipment. The cost to install the system is \$40,800, and it will save \$7,293 per year.

The fourth project is also for FHS, and will install a Variable Frequency Drive to control water flow. It will allow the system to change speeds as needed for recirculating water that is hot/chilled, instead of the pumps running at constant speeds. It will tie into the new energy management system. The project will use \$5,705 of the grant money and will save \$1,174 annually.

The remaining \$3,054, will be set aside as a retainer for SRPEDD (Southeast Regional Planning and Economic Development District) for consulting assistance.

"Their assistance was invaluable during the designation process and I would like to continue utilizing that relationship and knowledge," wrote Ms. McClees in her memo to the board.

The board voted to authorize the project to go forward, and allow Town Administrator Mark Rees to sign.

The board also received a recommended budget from Town Administrator Mark Rees, with an estimated total of \$50,978,082 in revenues and expenses projected for FY20.

In another matter the board voted to allow the previous owner of 30 Evergreen Street to redeem the property. It was taken for foreclosure due to nonpayment of taxes. The owner will have to pay all back taxes, fines, and legal fees.

The board also voted not to allow a spouse of a deceased town employee to get on the town's health plan, because the man was not on the plan

when his spouse died.

The town should have a policy in writing, said Human Resources Director Anne O'Brien.

The board voted to allow spouses to stay on the plan if they were already on it when the town employee died, but rejected the idea that a spouse could join the plan after.

In other business, the board:

- Appointed Bradford Perkins to the Municipal Fiber study Committee;
- Appointed Sallie Lou Johnson to the Dog Park Study Committee
- Granted an extension of the Purchase & Sale agreement for the Oxford School building. Mr. Rees told the board that the company is making progress on getting funding, and has overcome some hurdles that were slowing down the project.

Fairhaven Voters

Keep the BPW Independent
Stop the \$17,917 wage increase

The Fairhaven Selectboard is about to vote on an item that will amend the Wage Classification plan that will affect how much you will pay in water and sewer rates. It will result in a combined \$17,917 wage increase for water and sewer superintendents. At their 1/28/19 meeting, Selectboard members continued this item due to objections by members of the Board of Public Works.

The current, proposed vote for the **Selectboard's 2/27 meeting (note date change)** will place the two superintendents under the jurisdiction of the Town Administrator, an outcome that voters clearly DID NOT want when they voted to keep the BPW independent.

I am **urging** Fairhaven voters to call Selectboard members and ask them NOT to vote on the item at Monday's meeting, but to postpone it until the BPW can be added to By-Law 61-2 as exempt from the WC plan along with School Department employees. The BPW already has an article prepared for the next Town Meeting.

Please show your support again for the BPW and keep Fairhaven fiscally responsible. This change WILL increase your water and sewer rates, as these positions are paid from those funds.

FHS music students break records

Press Release

Fairhaven middle-school and high-school music students set new department records at the Junior and Senior Southeastern Massachusetts Bandmasters Association (SEMSBA) this past weekend.

Of the 34 total students sent, Fairhaven Music had 21 students accepted into either the Senior or Junior SEMSBA Festivals - a new district record for the music department.

From the Fairhaven High, 16 total students were accepted to the Festival - including a record-breaking



12 students from the choral program. This marks the third consecutive year that the FHS Choral Program has broken its own record for acceptance into the Festival.

In addition to the program's success over the weekend, two Fairhaven High Music students were also honored last month for their accomplishments in music.

Senior Frances Desrosiers was invited to present her work at a Young Composer's Master Class at this year's MMEA All-State Conference for second year in a row. She was invited for her award-winning original composition "A Peculiar Tale for a Trio" that was submitted to the MMEA All-State Conference Committee in January.

Finally, Bethany Tetreault was accepted into the MMEA All-State Chorus - an honor that hasn't been achieved by a Fairhaven High music student in over 7 years. This is the highest accomplishment that a choral student can achieve and gives Tetreault an opportunity to rehearse and perform with the top choral musicians in the state of Massachusetts.

The Senior Festival will take place March 22 - March 23, 2019 at Scituate High School while the Junior Festival is May 3 - May 4, 2019 with location



Man med-flighted after fire at McCormack Manor

Fairhaven Fire Dept. Press Release

At 6:07 p.m. on Saturday, 2/9/19, Fairhaven firefighters received a fire alarm box for McCormack Manor, at 157 Washington Street. Almost immediately after receiving the alarm, 911 calls were received reporting a fire in apartment 110.

Two engines and an aerial ladder responded. First arriving crews found heavy smoke coming from the rear of the multi-unit three-story apartment building. Firefighters made a quick entry and discovered the kitchen of the first floor apartment well involved

in fire.

Firefighters rescued a 66-year-old male victim from the apartment. The victim suffered from burns and smoke inhalation and was rushed to St Luke's Hospital. The patient was in serious condition on arrival at St Luke's and was later transported to Massachusetts General Hospital by Boston Medflight.

The fire was contained to the single apartment on the first floor, but the second and third floor apartments suffered smoke damage.

The fire is under investigation by the Fairhaven Fire Department assisted by the Fairhaven Police Department and the Massachusetts State Fire Marshall's office.

Carter sent to House of Correction

Michelle Carter, 22, the Plainville woman who was convicted of involuntary manslaughter in the suicide death of Conrad Roy III, reached the end of her options to avoid jail time and started serving her sentence at the Dartmouth House of Corrections on Monday, 2/11/19.

Ms. Carter was sentenced to 2.5 years in the HOC, with 15 months suspended and 15 months to be served. Juvenile Court Judge Lawrence Moniz stayed her sentence while her appeals were being heard in Massachusetts. The judge made it clear in his ruling in August of 2017, that he was allowing Ms. Carter to stay out of jail only during the in-state appeals process.

Mr. Roy was found in his pickup truck in the Kmart parking lot in Fairhaven on July 13, 2014, with a spent gas-powered water pump in the cab with him. He died of carbon monoxide poisoning.

The Mass. Supreme Judicial Court upheld Ms. Carter's conviction on 2/6/19. The Bristol County District Attorney's office immediately filed a motion to revoke the stay and have her remanded to custody.

Ms. Carter's attorneys filed a motion with Judge Moniz to deny that request and also filed an emergency petition with the SJC to keep Ms. Carter out of jail while she appeals to the United States Supreme Court. Both were denied. In a last ditch effort to keep Ms. Carter out of the HOC, Mr. Cataldo asked Judge Moniz on Monday to deny the DA's motion to revoke the stay.



Mr. Cataldo told the court that the case is "legally not over."

He said there is a "split among courts" that have handled cases similar to Ms. Carter's. He said her direct appellate review is going to the US Supreme Court, there are legal issues that are still relevant, and many of those legal issues are federal issues. He cited a couple of cases that disagree if advising suicide is a crime or not.

asked if there were any other issues to bring up on either side, but both the defense and the Commonwealth had clearly had their say.

He said he had reviewed the Commonwealth's motion and the order he issued in August, and considered it all.

"Ms. Carter will now be taken into custody," said Judge Moniz, and "the matter is adjourned."

The whole hearing lasted about five minutes.

Ms. Carter, who was 17 at the time of the crime, had cut her hair and was

dressed in a cream-colored suit jacket with elbow patches, looking much more like a 20-something professional adult than the teenager the defense tried to show to the court and the world during the trial.

She did not speak, but looked a bit nauseated during the whole proceeding, standing up immediately, even before, the judge spoke the words for her to be taken into custody. She rose from her seat and was led out of the courtroom by court officers, but not handcuffed.

Her parents were seated two rows behind her, but it appeared from the back of the courtroom and from subsequently released news video, that she did not look back at them.

Seven court officers lined the court room on both sides. Mr. Roy's family was there in force, taking up at least two rows. Ms. Carter's supporters were somewhat dwindled from the days of her trial, with her parents and maybe one or two others showing support outwardly.

After the court proceedings, Bristol County prosecutor MaryClare Flynn told reporters that it was a "long day coming." She thanked the Fairhaven Police Department for their "tireless efforts" and all the "work and dedication" they put into the case. She noted that the case was almost five years old.

"As always, our sympathies remain

Dog License Reminder

Dog Licenses are now available in the Town Clerk's Office. All dogs (indoor and outdoor) 6 months or older must be licensed by the Town Clerk. Each license is valid from January 1, 2019 thru December 31.

COSTS

- \$10.00: Spayed females and neutered males; \$15.00 for all unaltered dogs
- \$20.00: Kennel license for 3-4 dogs
- \$50.00: Kennel license for 5-15 dogs
- \$100.00: Kennel License for over 15 dogs

According to the Town of Acushnet By-Laws, all owners are required to license their dog(s) between January 1st and March 31st of each calendar year. If an owner obtains or takes possession of a dog(s) after March 31st, he/she must license their dog(s) within three months of possession. Failure to license will result in a \$50.00 citation fee and a late fee of \$15.00 for each unlicensed dog.

Failure to vaccinate your animals against rabies will also result in a \$100.00 citation fee for each animal. Please remember, State Law requires that you present a valid rabies vaccination certificate of dogs 3 months and older to the Town Clerk prior to licensing.

To license your pet by mail, please send us a copy of the rabies certificate from your Veterinarian, a check payable to the "Town of Acushnet," 130 Main St., Acushnet, MA 02743 and a self-addressed stamped envelope. The Town Clerk's Office will promptly return your rabies certificate, along with your 2019 Dog License and tag.



The papers are in: Acushnet & Fairhaven have real races

The annual election for town offices in both Fairhaven and Acushnet will be held on Monday, April 1, 2019.

Deadline for requesting nomination papers and turning them in has passed. It looks like both towns will have at least one contested race, although there is still one last chance for candidates to change their minds and have their names pulled.

Deadline to withdraw papers is Wednesday, 2/27.

Tuesday, March 12, 2019, is the last day to register to vote for the town election. The Town Clerk's office in both towns will be open until 8 p.m. that day.

In Fairhaven you may register to vote any day from 8:30 a.m. to 4:30 p.m., Monday through Friday, at the Fairhaven Town Clerk's Office, Town Hall, 40 Center Street, Fairhaven.

In Acushnet, you may register to vote at the Town Clerk's Office, Parting Ways Building, 130 Main St., Acushnet, Monday, Wednesday, Thursday 8:00 a.m.-4:00 p.m., Tuesdays 8:00 a.m.-7:00 p.m. Fridays 8:00 a.m.-11:30 a.m.

Mail-in voter registration forms are available at both Town Clerk's Offices, the Millicent Library in Fairhaven, and state and federal offices throughout Massachusetts. You may also register to vote online at <https://www.sec.state.ma.us/ovr/>

Polling Places

Polling places for Fairhaven's town elections are: Precinct 1, Town Hall; Precincts 2 & 3, Hastings Middle School; Precinct 4, Fairhaven Fire Station; Precincts 5 & 6, Recreation Center. Polls are open from 10 a.m. to 8 p.m. on 4/1/19.

All precincts in Acushnet vote at the Elementary School on Middle Road.

Who's up for re-election and who's running?

Fairhaven:

Do we have a race or two?

In Fairhaven, Selectboard member Daniel Freitas is up for re-election. He will face challenger Lisa Plante. Both have returned papers and will be on the ballot.

For the Board of Public Works, one seat is up for re-election, held by Michael Ristuccia. Albert Martin, whose bid for a seat on the BPW ended in a tie last year, has returned papers for that seat.

Frank Coelho has also returned papers for that seat, so we have a contest for the BPW.

Mr. Ristuccia, however, did not take out papers for his seat. He pulled out papers for the Planning Board, but then did not return them, so he will not be on the ballot.

The School Committee has two seats up this year, but only one candidate. Incumbents for those seats are Michael McNamara and Stasia Powers. Both pulled papers; Ms. Powers returned hers, but Mr. McNamara did not return his by the deadline. Diane Hahn also pulled papers for one of those seats, but did not return them.

The Town Clerk seat is also on the ballot for a full term this year. Technically, it is vacant, because former clerk Eileen Lowney retired. Her assistant, Carolyn Hurley has been appointed acting Town Clerk. Ms. Hurley returned her papers with the proper number of signatures, and will be running unopposed.

For the Board of Health, Peter DeTerra is up for re-election. He returned his papers on 12/4/18, and has no opponent.

For Commissioner of Trust Funds, Barbara Acksen is up for re-election. She has returned papers for her seat and will run unopposed.

There are two people up for re-election on the Planning Board, Rene Fleurent and Wayne Hayward. Both have returned papers for their seats and will run unopposed.

There is also an unexpired term for PB, vacated when Nicholas Carrigg resigned. John (Jay) Malaspino was appointed to that position and has taken out papers to run. However, he did not return papers by deadline, so it will be a blank spot on the ballot.

The Housing Authority also has one five-year seat on the ballot this year, currently held by Anne Silveira. Three people pulled papers for that seat, but only Ms. Silveira and Nicholas Sylvia returned them. But we do have a race, with the two vying for one seat.

Acushnet: We have a race!

In Acushnet, the only contested race is for Selectboard.

David Desrosches is challenging incumbent Michael Cioper, who both returned papers.

For all other seats, the incumbents will be running unopposed, except for Library Trustee. Long time member Krisen Leotte decided not to run and no one pulled papers for that seat.

Incumbents who will be running unopposed are: Thomas Fortin, Board of Health; Libero DaSilva Soares, Board of Assessors; Sarah Gomes and Jennifer Downing, School Committee; Nancy Francis, Trustees of the Free Public Library; Charlene Fortin, Cemetery Board; Marc Laplante, Commissioner of Trust Funds; Christopher Anderson, Park Commissioner; Andrew Gomes, Housing Authority; Richard Ellis, Planning Commissioner.

it will run from June 1 through September 14, with the exception of June 29. On the Saturday following the end of the marketplace, 9/21, the seventh annual Harvest Fun Day will be held at the same location. Huttleston Marketplace vendors have the option of adding Harvest Fun Day to their schedule.

Vendors may sign up for single Saturdays of their choice with a donation of \$20 for an 11'x11' space. There is a nine-week discount rate of \$100 for any nine weeks, and a full season discount of \$150 for the 15-week season. That works out to \$10 per week. (Plus another \$20 can be tacked on for Harvest Fun Day.) Some vendors sign up for one or two Saturdays at the beginning of the season and then add on dates at \$20 each as the summer goes on. One

does not need to choose all of the weeks at the beginning of the season.

Categories for Huttleston Marketplace vendors are:

- arts, crafts, photography (crafts must be handmade.)
- local authors
- antiques, vintage collectibles, used books
- whole fresh farm produce, plants
- prepared food (requires food vendor permit from BOH)
- the Huttleston Marketplace does not accept representatives/consultants for commercially produced, direct sales products.

The cost of the space is a donation to the Tourism Gift Account and that money is used to promote the marketplace, purchase related supplies, and to hire local musicians to perform during the day.

Last season a total of 65 vendors participated during the course of the season. Each Saturday there were about 30 to 35 booths set up. The majority of vendors are eager to return in 2019, and we expect the marketplace will grow in its second season.

with the family of Conrad Henri Roy III, and we are grateful for the family putting their trust in the Bristol County District Attorney's Office," said Ms. Flynn. "We are very content with what happened today in the courtroom."

Mr. Roy's aunt, Becki Maki, also spoke to reporters on behalf of the family. She thanked Fairhaven police and the DA's office, and the court advocate for helping the family understand the court system.

"So this has been a four-year ordeal for our family. It's been four-and-a-half years since Conrad passed," said Ms. Maki. "And our heart has been broken this whole time."

She said it was hard for the family to live out the details of his death over and over.

"And it is something that has affected our minds," she said, adding that they were happy the proceedings on Monday ended the process for them.

They realize it may go to the federal courts, she said, "But this is the last time we'll be in this court. This is the day that we have been looking forward to coming to an end of our involvement in this case."

"We feel justice has been served," said Ms. Maki.

She also said the family knows it is a "novel case," and that there is a lot of debate on whether or not Ms. Carter should go to jail.

"So we really are grateful to the court for seeing that this is something that shouldn't have happened," she said. "And hopefully it will never happen again."

The case did help the family understand why Conrad died, said Ms. Maki. Conrad was in a place where he was recovering from his mental health issues, so reading the text messages

helped them understand they were part of the reason.

"That he had somebody he trusted and confided in that steered him in the wrong direction," said Ms. Maki.

"Conrad will be forever missed," she said, adding that through the case, his story has "touched so many hearts."

The only good that can come of it is that people who are struggling will know to get help.

"We hope that no one else ever has to deal with this pain," said Ms. Maki. "His life mattered. It mattered to us, and I think it mattered to a lot of people. Conrad, we love you."

Ms. Carter's attorney also spoke to

reporters outside the courthouse. He said that he would file an appeal directly to the US Supreme Court. He cited several cases throughout the country that differ in their findings in similar cases.

"Make no mistake, this case is not over," said Mr. Cataldo, and added later about the courts. "They got it wrong."

He has, since the beginning, said that Ms. Carter's texts were protected free speech. He emphasized that she was a teenager who also had mental health issues at the time of Mr. Roy's death, and that she is a different person now.

Mr. Cataldo said he did not think anyone could be prepared for going

to jail for something that she did as a teenager, and that her life has been on hold for four years.

Mr. Cataldo said that although Ms. Carter is a different person now and would never do the same thing, she does not understand how she could be prosecuted for helping Mr. Roy do what he wanted to do. He left her a love note, noted Mr. Cataldo.

"She's being put in jail for something he wanted," he said.

He also noted that Mr. Roy told her to delete her text messages, but she did not, because she did not think she was doing anything wrong.

"It was Conrad who told her to delete all the text message," said Mr. Cataldo. "She said, 'why'?"

The courtroom proceedings in Taunton ended at 2:05, and Ms. Carter was in Dartmouth at the HOC a little after 3 p.m., according to Bruce Assad, Special Sheriff of Bristol County who addressed the press in Sheriff Thomas Hodges absence just after Ms. Carter's arrival on Monday.

Mr. Assad said that Ms. Carter would first be in the medical unit on "eyeball watch" 24/7 until it was clear that she would be okay to join the general population. He said they will watch her based on her "age, circumstances and the high profile nature of the case."

After she is evaluated by the medical and mental health teams, she will transition to the general population and will be treated the same as everyone else, he said.

According to her attorney, she will be eligible for parole after serving half her sentence, or 7.5 months. Parole is not guaranteed and depends on a number of factors, including what kind of behavior she exhibits while incarcerated. •••
