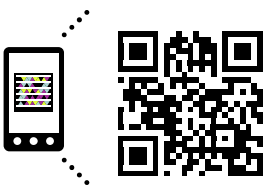

Silvia ignores his conflict, alleges new conflict for Espindola

The search for a permanent town administrator was further delayed on July 28 when Fairhaven Select Board member Keith Silvia interrupted the discussion during the meeting to request that the board table the matter due to what he perceived as another potential conflict of interest.

Mr. Silvia himself is prohibited from any discussion about the town administrator search because of his own conflict of interest, which, according to the State Ethics Code, should prevent him from participating in the matter. Mr. Silvia has been recusing himself and exiting those discussions since February because his wife, Anne Silvia, is the director of the Council on Aging and directly supervised by the TA.

State Ethics defines participation as "approval, disapproval, decision, recommendation, the rendering of advice, investigation or otherwise," under Section 1 of the Conflict of Interest Law (G.L. c. 268A). The State Ethics Commission's published guidance on the law further clarifies:

"Often, discussing, providing advice or making recommendations about a particular matter may have more of an effect than the employee's single vote."

On 7/28, Mr. Silvia interrupted Mr. Espindola and said, "I would like to see if we can table this ... because I think there might be another conflict of interest that came up. I spoke with [Town Counsel Tom Crotty]. "He's on vacation, he'll be back on [August 2]. He said he'd look into it and let me know.

"I know that this is pressing and it's important," Mr. Silvia continued, "but I didn't want to get us into anymore problems..."

Mr. Silvia would not provide details about the supposed conflict of interest.

"I really didn't want to get into it; I wanted Attorney Crotty to address it," said Mr. Silvia. He then said that by the next regular meeting, "If everything is clear, then we can go (forward)."

Mr. Silvia disregarded his own conflict of interest by participating in the discussion on 7/28 and obstructed

the TA search process from progressing that night. Mr. Espindola tabled the discussion until the next regular meeting on August 9, with the stipulation that a special meeting could be scheduled before then.

After the meeting, when the *Neighb News* pointed out to Mr. Silvia that he had essentially violated the Conflict of Interest Law out of concern for someone else's potential State Ethics violation, his reply was, "Whatever."

When asked to clarify what he meant, he stated, "I thought it was the right thing to do."

In a phone interview on August 1, Mr. Espindola disclosed that the alleged conflict of interest Mr. Silvia was referring to involves Mr. Silvia's wife who, as COA director, recently made Mr. Espindola's sister, Donna Dwelly, an unsolicited offer of employment to fill a brand-new position at the COA as lead activity aide.

According to Mr. Espindola in a July 30 email to Atty. Crotty and subsequently filed with the Town Clerk's Office, Ms. Dwelly was not actively seeking employment with the

BPW studying possible rebuild of causeway

If you drove on Causeway Road in Fairhaven almost any day last week, you may have noticed that surveyors with various kinds of equipment were milling about the place, taking measurements and checking out every little thing.

The Fairhaven Board of Public Works hired Tighe and Bond to go the next step from a study they did back in October of 2020. The company is looking at ways and costs to replace or repair the causeway/bridge. Six alternatives, four short term and two long term, range in cost from \$3,630,000 to \$22,710,000.

Sea level rise due to climate change is a major concern, with access to the island in jeopardy.

“Long term alternatives include solutions for the bridge and causeway to accommodate coastal resiliency, potential impacts from climate change, and potential sea level rise,” reads the 10/29/20 report. “Short term alternatives include solutions that upgrade the existing

bridge to meet current codes and to modify the causeway for improved safety and overall functional performance.”

Short Term alternatives include: Rehabilitate bridge, replace bridge, approach rails for short term alternatives (two options), options to maintain traffic while working on short term alternatives.

Long term alternatives, which include elevating the road by five feet, include: Replace bridge and upgrade causeway with 28-foot span on concrete beams; replace bridge and causeway with a 600-foot bridge in piles.

Public works superintendent Vinnie Furtado said the causeway bridge is inspected by the state every two years. He emphasized, that although it has some deterioration, it is sound and not in danger of collapsing. Sea level rise is an issue, he said, with the water splashing over the road more often.

Any new construction, should widen the road and elevate it.

Mr. Furtado said the options range

from just repairing what it there, to a complete rebuild.

He said the board wanted to at least assess the situation to get options in line.

“Before there’s a problem and everybody needs to swim who lives on West Island, I want to tackle this.”

He said the work going on this month is an assessment, first to verify the state’s work.

“And we’ll take it from there as to, aer we going to fix what’s there or fix it with an upgrade, or are we going to build a whole new bridge,” said Mr. Furtado.

He said the company will also help the town find grant money from the state.

“The idea is to fix the bridge and then do guard rails beyond the bridge on both sides, because we can get money for that, too,” said Mr. Furtado. “We want to incorporate sea level rise so it would be higher than what is there now. It has to be higher.”

Tara Kohler named superintendent in Fairhaven

The Fairhaven School Committee voted unanimously to appoint Assistant Superintendent of Schools Tara Kohler to the superintendent position at its 7/28/21 meeting.

Superintendent Robert Baldwin notified the district that he would not finish out his contract to take a position as Executive Director of the Massachusetts Interscholastic Athletic Association (MIAA) and the Massachusetts School Administrators Association (MSAA).

SC chairperson Brian Monroe said that typically, for major leadership positions, a committee would hire a consultant and go through a full search process to cast a wide net and bring in resumes from far and wide. Then the committee would review and have meetings and interviews to select the best candidate.

"However, in this case, we have the best candidate," said Mr. Monroe.

He said the committee has had the opportunity to get to know Ms. Kohler starting with her appointment as principal of Fairhaven High School in 2008. He said she did "wonderful things" at the high school, making it one of the best in the South Coast.

Then she took on the broader role of assistant superintendent and "has grown tremendously as a leader," said Mr. Monroe.

He added that COVID-19 put her to the test and was going to either make or break them.

"It just made her all the much better," he said.

"I couldn't be happier for you and our school district," said Mr. Monroe. "And I'm just very excited to see where we're going to go, and how

we're going to grow and the new direction, and it's going to be awesome."

SC member Kyle Bueno reflected on his time at the high school when Ms. Kohler was his principal. Mr. Bueno said she saw in him the passion for public service and the passion for giving back to community and invited him to intern for the School Committee.

He said her passion shows she was born for the education roles she has had.

"This role is so deserving for you," said Mr. Bueno. "I can only imagine what you're going to build upon from Dr. Baldwin's leadership, and I'm just excited to see your leadership potential in this new endeavor."

SC member Colin Veitch said he "obviously touted Dr. Baldwin's ability to hire and coach great talent," adding he did a great job with Ms. Kohler.

"I can't wait to see how you paint the canvas of the Fairhaven Public School district in the future," said Mr. Veitch. "We've all come to know you and love you, and I have confidence in you. You'll be great."

"I'm thrilled," said SC member Donna McKenna.

She said Ms. Kohler did a great job as principal and as assistant superintendent, and could only go further to create a better district.

"The opportunity to have another great superintendent in charge is awesome," said Ms. McKenna.

SC Vice Chair Pam Kuechler said it has been "exciting" getting to know and watch Ms. Kohler, and noted they started on the same day. She added it's exciting to transition.

"Transitions are tough," said Ms.

Kuechler. "But they're not tough. Because this provides us with a level of continuity."

She said because Ms. Kohler has been there, she knows them, she has ideas and they will "reap the benefits of that."

She said now the district will benefit of Ms. Kohler's own set of talents.

"And when we ask that question, 'what's next,' you've already heard it and though about it," said Ms. Kuechler. "I'm thrilled. I'm so happy for you...for everything you've done for the district."

Mr. Monroe made his first point rather forcefully.

"The thing to remember is that this is yours now, right," said Mr. Monroe. "You are in charge of this and as Mrs. Kuechler said I'm sure you have a lot

Recipe of the Week

Angry Shrimp

- 2 tablespoons pumpkin seeds
- 1/2 cup golden raisins
- 2 tablespoons olive oil, divided
- 3/4 cup diced white onion
- 1/4 cup dried cherries, chopped
- 2 teaspoons chipotle powder
- 4 tsps chopped garlic, divided
- 1/2 teaspoons ground cumin
- 1/2 cup Grand Marnier orange liqueur
- 20 oz low-sodium vegetable broth
- 1 tablespoon cornstarch
- 2 lbs medium-large shrimp, peeled and deveined, thawed if frozen
- 1 tablespoon orange zest
- 6 cups kale, stems removed, chopped
- 3 cups cooked brown rice

In a small pan over high heat, toast pumpkin seeds, stirring constantly, until lightly brown, 1 to 2 minutes. In a food processor, puree raisins and 1/4 cup water 1 minute.

In a large pan over medium heat, heat 1 tablespoon oil. Add onion; cook until translucent, 5 mins. Stir in raisin puree, cherries, chipotle, 1 tsp garlic and cumin; cook 1 minute. Add Grand Marnier and cook, stirring, until alcohol is cooked out, 1 to 2 minutes.

Add broth and bring to a boil, then reduce heat and simmer. In a bowl, dissolve cornstarch in 1 tablespoons cold water. Gradually add cornstarch mixture to broth mixture to thicken; reduce heat and simmer 7 to 10 minutes. Add shrimp; cook until pale white, 5 minutes. Stir in zest; season with salt and pepper.

Transfer to a bowl and set aside.

In pan, heat remaining 1 tablespoon oil. Cook kale and 3 teaspoons garlic, stirring, until kale starts to wilt, 3 to 5 minutes. Strain juices and combine with rice. Divide rice mixture, shrimp and seeds among 6 plates. www.epicurious.com

Fairhaven Selectboard: Espindola is chair, Powers is vice chair

Select Board member Bob Espindola was voted chairperson during the July 28 meeting, followed by the nomination of board newbie Stasia Powers as vice-chair.

When Select Board member Keith Silvia nominated Ms. Powers as vice-chair, she was visibly surprised.

“Are you sure you’re not interested?” Mr. Espindola asked Mr. Silvia, suggesting that he was going to nominate Mr. Silvia as vice-chair.

Mr. Silvia replied that Ms. Powers’s 14 years on the School Committee was enough to merit the nomination. Later during the meeting, when the board would grant the special event permit for the South Coast Bikeway Alliance’s September 12 Pedal for the Path fundraiser, Ms. Powers would act as chair during her first meeting as on the board when Mr. Espindola, a member of the alliance, recused himself.

Tree Warden Don Collasius was listed on the agenda to talk about tree warden issues and began by asking, “Who do I report to?”

“Elected officials report to the voters,” replied Mr. Espindola.

“So, the voters are my boss,” said Mr. Collasius.

He followed with questions concerning insurance and liability on behalf of his part-time workers should they get injured during the job. He then asked Interim Town Administrator and Finance Director/Treasurer/Collector and apparent Director of Human Resources Wendy Graves about said coverage looking for specific information and amounts. She could not provide him with the answers.

Mr. Espindola suggested that Mr. Collasius could have submitted those questions ahead of the July 28 meeting, and Mr. Collasius said that he did in a July 9 email but did not get any response from Ms. Graves, who shook her head ‘no.’

Mr. Collasius wanted to know if one of his workers dies on the job what compensation would their family receive and what is the level of exposure to the Town?

Mr. Collasius gave his interpretation of Mass General Law Chapter 87, stating that he is responsible for shade trees on town property, but when “A shade tree lying on the

ground provides no shade.”

Given the discrepancy between how Mr. Collasius interprets the law and what the Town believes are his responsibilities, Mr. Espindola suggested that town counsel should be consulted to resolve the matter immediately; however, Mr. Collasius said that he asked for access to town counsel and was “stymied.”

Ms. Graves said that she had “gone above and beyond to help” Mr. Collasius.

When he complained that she did not respond fast enough, Ms. Graves said she gets too many emails every day, and when she seeks advice through a listserv, it can take days for other municipal employees on the listserv to answer her question.

She added that she was on vacation the week Mr. Collasius contacted her, “And I deserve to have a vacation.”

Public works Superintendent Vincent Furtado spoke via Zoom and said the Board of Public Works realizes that Mr. Collasius has concerns; however, during a storm or emergency, the public works department only moves a tree limb to the side of the road until the tree warden can tend to it.

“That’s the way we have always done it,” Mr. Furtado said. He agreed that there should be a tree department, more than a tree warden and a “random two people” that may or may not be available at the time to come into work.

Ms. Powers said she hoped to resolve the issue through collaboration. The police and fire chiefs both confirmed that tree limbs blocking the roadway would generally be pushed aside until the tree warden was available to remove it.

The board agreed to review the liability insurance and workers’

compensation to ascertain whether there is any risk to the Town and revisit the matter at a later time.

Earlier in the meeting, BPW member Marcus Ferro approached the lectern and spoke as a Precinct 4 member expressing his main concern about the tree warden. Mr. Ferro cited M.G.L. Chapter 87, which he said “makes clear” that the tree warden is responsible for the care and removal of public shade trees and that he supports creating a tree department under the Department of Public Works.

He said he supported Mr. Collasius’s prior recommendation of a tree department under the oversight of the BPW.

“But now all I’ve seen are [social media posts] and soliloquies” on what Mr. Collasius thinks the tree warden’s responsibilities are, said Mr. Ferro.

Mr. Ferro said in his opinion, that Mr. Collasius is an “elected official looking at ways to not do their job” and then further added, “A resignation might be a more palatable option.”

Mr. Ferro left before Mr. Collasius’s agenda item was brought up.

The board also heard from Precinct 4 Chairperson Paul Foster, during the board’s precinct meet and greet and said that while he did not

have a chance to contact a significant number of Precinct 4 residents ahead of the meeting, the feedback and concerns he has heard related to the "craziness over the appointment of the town administrator."

Mr. Foster said many residents believe the new permanent TA should be qualified and possess adequate experience. He mentioned concerns over adequately funding town departments and keeping an eye on the tax rate.

In other matters, the board briefly discussed changes to the Rogers Re-Use Committee mission statement and the composition of the committee, increasing it from a five-member committee to a seven-member, to include a member from the Economic Development Committee, the Planning Board, and the Finance Committee.

Ms. Powers noticed that the website specifies that Director of Planning & Economic Development Paul Foley is the staff representative and contact person for Rogers Re-Use matters, which Mr. Espindola emphasized should be followed when developers, engineers, or consultants attempt to communicate with the Town.

Committee member Susan Loo clarified that committee members have never served as the point person for contact with interested parties, and responses to requests for proposal (RFPs) have always gone directly through the Town, not the committee.

"They always went to the Select Board, and the Select Board would pass them onto us.... That really needs to be clarified," said Ms. Loo. "No RFP ever came directly to us. None. None."

She added that there is ample "misinformation out there" saying otherwise.

Earlier in the meeting, Mr. Foley discussed the possibility of receiving funding for the future of Rogers School from a MassDevelopment grant to fund a new feasibility study to update the projected costs involved in developing the old school and bringing it up to code for future use.

He added that funding could also go toward the RFP process. His preference would be to apply for up to \$50,000 to accomplish a combination of both objectives. Any request for over \$50,000, he said, would require a community match of funds. He also specified that if the Town accepted the grant money and then later sold the school property, the Town would have to return the money to the state. He will submit the application by the August 6 deadline with the support of the Select Board.

Mr. Foley also mentioned that the Economic Development Committee is looking for new members and people send letters of interest to the Select Board by August 9.

Also during the meeting, Acting Town Clerk Linda Fredette swore in the Police Department's newest full-time officer, Zachary Vieira. Mr. Vieira has a bachelor's degree in criminal justice, is a certified 911 dispatcher, and has served as a part-time officer in Fairhaven for some time. He graduated from the Plymouth Police Academy on July 23.

Police Chief Michael Meyers said Mr. Vieira did an "outstanding job" at the academy, even smashing the academy's 20-years long speed record for the 1.5-mile physical standards requirement, winning himself a

special award. The standard is to complete the distance in under 13.5 minutes, but Mr. Vieira finished in 7 minutes and 42 seconds, beating the record of 7 minutes and 58 seconds.

"He made us proud, and he made Fairhaven proud, that's for sure," said Chief Meyers.

"I'm just very excited to support the community where I grew up, and I'm looking forward to the journey," said Mr. Vieira.

In another matter, Ms. Graves reported that there would be some changes for the upcoming tax possession auction scheduled for Tuesday, September 28. The list has changed due to the Conservation Commission's interest in retaining some of the properties, and some additional properties were added to the list.

During the board's reorganization, the board reassigned the appointments of former SB member Dan Freitas, who was recalled in the 7/26 election. Board members approved all except the role of contract compliance officer. When asked what the duties are of that role, Ms. Graves was unable to inform the board. That appointment will be taken up at the board's next meeting to get a clarification of the duties.

The board granted a special event permit for the Turkey Trot 5k on November 25, Thanksgiving morning. The event collects canned goods and non-perishables for the Shepherd's Pantry in Acushnet.

In light of Zoning Board of Appeals member Joe Borelli's resignation, the Town will advertise for a new associate member. Those interested in serving may send a letter of interest to the Select Board by August 5.

Bill to make Selectboard five members is in legislature

Town Meeting voted on 6/12/21 to increase the number of Select Board members to five, from three. But that was not the end of it. The change needs to be approved by the legislature.

Mass. State Representative William Straus, who represents Fairhaven, introduced House No. 3948 on 6/22.

The bill calls for three members to be elected the first year. The highest

vote-getter will serve three years, the second highest will serve two years, and the third will serve one year. After that, each will serve three years.

"This act shall take effect upon its passage," reads the bill.

Rep. Straus's office said in an email that the bill was referred to the Municipalities and Regional Government Committee on July 14 and concurred by the Senate on July 15. The bill is currently pending a committee hearing. After a public hearing

date is set, the office said it will have a better idea of the timeline.

Nomination papers in Fairhaven are generally available by December 1 for the following April's election. It is unclear how much time the town needs to be able to include the changes for the next election.

Acting town clerk Linda Fredette said in an email that she was not sure of the answer. She said she sent a message to the Secretary of State, but did not hear back by press time.

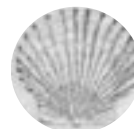

BPW discusses Lavalette's behavior as beach parking attendant

At its meeting on Monday 7/26 the Fairhaven Board of Public Works met with Brown and Caldwell about new recycling center plans, discussed Cooke Park signage and met with a resident about issues at Town Beach.

The board first met with Brown and Caldwell to discuss updates on the recycling center plans.

BPW Superintendent Vinnie Furtado informed the board that he will be taking the employees of B&C visit the current recycling center and then to the proposed new location on Bridge Street.

Brown and Caldwell representative Sam Chapin explained to the board that they spoke with the Massachusetts Department of Environmental Protection, and they have plans to meet with them via Zoom and invited board members to join.

Board member Cameron Durant asked what will be discussed at the meeting.

Mr. Chapin said they will explain a summary of the current and new location, as well as why the recycling

center needs to be moved and what the time frame of the project will be.

Mr. Chapin said they will also be asking the DEP if more permits and assessments are required for the new property. He said they need to ask the DEP what actions need to be taken to be able to use the property on Bridge Street as a new recycling center.

Vice Chairperson Robert "Hoppy" Hobson said that the recycling center does not require any digging into the ground. He said it is just a place to store recyclables, such TVs, mattresses, couches, metal, and brush, like yard waste.

Chairperson Brian Wotton said that after the meeting with the DEP the board can meet with Brown and Caldwell again for an update on what the next steps will be.

In another matter board member Marcus Ferro and Mr. Wotton brought up issues with the new Tree Warden.

Mr. Wotton said the Tree Warden is refusing to trim trees or go out in storms to remove fallen trees. Mr. Wotton said it is ridiculous, but the BPW will go get any tree that has fallen and is blocking a roadway even

though it is the Tree Warden's job.

Mr. Wotton said he calls for the Tree Warden to resign and go to town meeting and officially make Mr. Furtado the town Tree Warden.

Mr. Wotton said the tree situation in town is "disgusting, embarrassing, and unacceptable."

Mr. Ferro said it is ridiculous that the Tree Warden has publicly stated that he will not go out in a storm to remove trees and has left the BPW to pick up his slack.

Mr. Ferro said the Tree Warden needs to stop complaining on Facebook and resign.

Mr. Wotton said if the Tree Warden wants to do justice for the town he needs to step down from his position.

Mr. Furtado said it will need to be brought in front of town meeting.

The board also unanimously approved the revised water and sewer abatement policy that states a licensed plumber and town Water Department employee must check the property for leaks; and allows residents to get a second water meter.

The second water meter allows

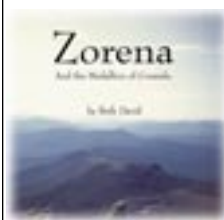

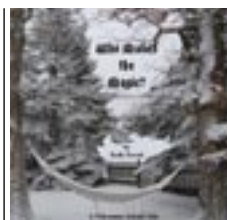

COA when Ms. Silvia contacted her to offer her the position. However, Ms. Dwelly was once associated with the COA before the 2020 pandemic during a time when, through Coastline Elderly Services, she provided services to the COA as part of a grant-funded program.

Mr. Espindola wrote in his email to Mr. Crotty, "To be honest, this whole scenario and the timing of it seemed odd to me from when I first heard about it."

He said Ms. Dwelly informed him of Ms. Silvia's job offer and also that, "Anne Silvia was pressuring her to make a decision in a certain time frame.... Quite honestly, I felt the timing and circumstances were suspicious at the time."

Something else Ms. Dwelly told him also concerned him, Mr. Espindola wrote in the email: "Anne Silvia said to her (during the process of offering my sister the position), 'Well, I don't know how this will work with my husband unable to participate in the TA search and your brother unable as well'"

Mr. Espindola said that, before his sister accepted the position, he contacted the State Ethics Commission and received a written response from Amy Nee. In that response, which Mr. Espindola also filed with the Town Clerk, Ms. Nee stated that under Section 19 of the Conflict of Interest Law, a municipal employee may not participate in a particular matter if he or an immediate family member has a financial interest in the matter.

Ms. Nee then concluded, "Your sister's immediate supervisor would be the [COA] Director [and] not the [TA]. Unless the new [TA], once appointed, would be making

decisions imminently about your sister's wages, hours, or working conditions, your sister's financial interests would not be affected by who the [TA] will be."

Nonetheless, Ms. Nee offered Mr. Espindola two options: to recuse himself if he felt he could not be impartial, or file a 23(b)(3) disclosure form "explaining the task you are expected to perform as a Selectman and the relationship ... that could cause a reasonable person to suspect undue favoritism or improper influence..."

The disclosure was filed with the Town Clerk on July 28 before the Select Board meeting.

Mr. Espindola also attached to his disclosure a July 14 email Ms. Silvia sent to him informing him that she had offered the position to Ms. Dwelly. She said Ms. Dwelly had wanted to wait until any concerns Mr. Espindola had about the matter were resolved before committing to the position, and wrote, "I am asking that you please get back to me today or tomorrow with an answer. I have to know what I am doing staffing wise asap to ensure the program is staffed appropriately," Ms. Silvia wrote.

The *Neighb News* sent Ms. Silvia an email on August 2 asking her how she came to create the new position, whether she knew Ms. Dwelly was Mr. Espindola's sister, and whether she made any comment to Ms. Dwelly similar to the one Mr. Espindola stated in his email about Mr. Silvia and Mr. Espindola not being able to participate in the TA search process.

The *Neighb News* also asked Ms. Silvia about a number of payments, including one for \$338.69 from 12/13/13 made out to Keith Silvia

Custom Builders for work performed at the Senior Center.

In a Freedom of Information Act (FOIA) request the *Neighb News* submitted on February 22 this year, records show that Mr. Silvia has received multiple payments for work performed for the town, including one payment dated 7/15/20 totaling \$698.82 for work performed at the Academy Building. Mr. Silvia had already been elected to the Select Board and serves as the board's representative to the Historical Commission, which oversees the Academy Building.

In addition to his conflict of interest violations related to the appointment of Interim Town Administrator and his interference, which resulted in Ms. Graves's reconsideration as a fourth TA candidate apart from the three selected by the TA Search Committee, Mr. Silvia has also potentially violated the Conflict of Interest Law by accepting at least one payment for work to the Town post-election.

Ms. Silvia, as director of the COA, is also potentially in violation of the COI Law by using her husband's business to perform work at the COA. The *Neighb News* also asked Ms. Silvia if she had filed any State Ethics disclosures with the Town Clerk's office pertaining to her husband's company.

The *Neighb News* has filed an additional FOIA request for further information into Mr. Silvia's payments, and we will report further on them at a later date.

Ms. Silvia did not respond by press time to two emails on two separate days seeking comment for this story.

of great ideas you want to implement.”

He said she has seen how they operate as a committee and she should “run with it, do what you think is best. And we’re here to support you.”

Ms. Kohler told the committee that she realized they had a “lot of options” on what to do after Dr. Baldwin announced that he was leaving.

“I couldn’t be more thankful to you for having the trust in me to do that,” said Ms. Kohler, adding that she remembered the intimidating committee interviews.

“To hear the words you said tonight means a lot,” said Ms. Kohler. “I just can’t thank you enough. I am humbled by it. And I promise to bring a lot of great new ideas.”

She also said she loved Fairhaven, her family moved to town and, “I’m truly dedicated to it.”

“I feel like I’ve put blood, sweat and tears into this place,” said Ms. Kohler, adding that COVID-19 definitely helped her grow. “I appreciate your support and I look forward to doing this.”

She said following someone like Dr. Baldwin will be tough shoes to fill, “But I hope to do it well,” she said.

residents to have one meter for the house and one for yard watering, which would only charge for water, not sewer. Mr. Wotton said he would like a copy of the policy to be sent to every resident when the next water and sewer bills go out.

In another matter the board reopened the discussion about placing a memorial anchor at Cooke Park, as well as signage stating what it memorializes.

Mr. Wotton said at the last meeting the board decided to table the topic to see if other residents wanted to speak on it, but no resident showed up to discuss the matter.

Mr. Wotton recommended that the board add the anchor to Cooke Park in the drainage garden area and then ask the Historical Commission to come up with signage or a plaque.

Mr. Ferro agreed and also said that the Historical Commission should acknowledge the undocumented/unmarked graves.

Mr. Durant agreed and said the Historical Commission should come up with the verbiage for the sign and the board can approve it.

The board voted unanimously to place the anchor in the drainage garden and send a letter to the Chairperson of the Historical Commission to request the verbiage for a sign/plaque.

In another matter the board met with resident Mary Anne Walker about a confrontation she had with Town Beach parking attendant Gary Lavalette.

Ms. Walker explained that she took her grandchildren to the beach one day and parked her car in the lot by the tower. Ms. Walker said Mr. Lavalette came running at her and yelling at her that she could not park

there.

Ms. Walker said she told Mr. Lavalette that she parks near the tower all the time and she can park there, but that Mr. Lavalette just did not want her to.

Ms. Walker said that Mr. Lavalette told her that she needs to park where he tells her to park and that he raised his voice at her and spoke in a derogatory tone.

Ms. Walker explained that she then moved her car to where Mr. Lavalette suggested and started unpacking her

car with her grandchildren and their boogie boards.

Ms. Walker explained that she knows the rules and the kids can use their boogie boards on the other side of the lifeguard signage and rules. Ms. Walker said she explained that to Mr. Lavalette and told him that she would be monitoring the children.

Ms. Walker said as Mr. Lavalette was arguing with her about the boogie boards another car pulled in and Mr. Lavalette started yelling at them as well that they needed to park where he told them to park.

Ms. Walker said that she and Mr. Lavalette argued back and forth for awhile and she said she did yell and get quite loud with him as well.

Ms. Walker explained that Mr. Lavalette also threatened to call the police on her. Ms. Walker said she is now very uncomfortable going to the beach when Mr. Lavalette is there because she does not know what might happen next time. She said he was very unwelcoming and he scared her grandchildren.

Ms. Walker said she is worried for other residents or visitors that come to Town Beach and have to deal with Mr. Lavalette's demanding and unwelcoming attitude.

Ms. Walker said Mr. Lavalette needs to find a better way of speaking to people.

Mr. Hobson apologized that Ms. Walker had that happen to her. He said he was not trying to stick up for Mr. Lavalette but he said that they really needed him at Town Beach and he does great things down there.

Mr. Furtado said they need Mr. Lavalette's skills with parking to help fit the most amount of cars in the lot safely. Mr. Furtado said the way Mr. Lavalette spoke to Ms. Walker was very wrong and he apologized for that.

Ms. Walker suggested putting tar in the parking lot and adding lines so they do not need a parking attendant.

Mr. Wotton said it is a costly project, but it is something the board is working on.

Mr. Ferro suggested that the board ask Mr. Lavalette to attend the next BPW meeting during an executive session to discuss the situation and how he can speak better to residents.

Mr. Wotton said they will add it to next meeting's agenda.

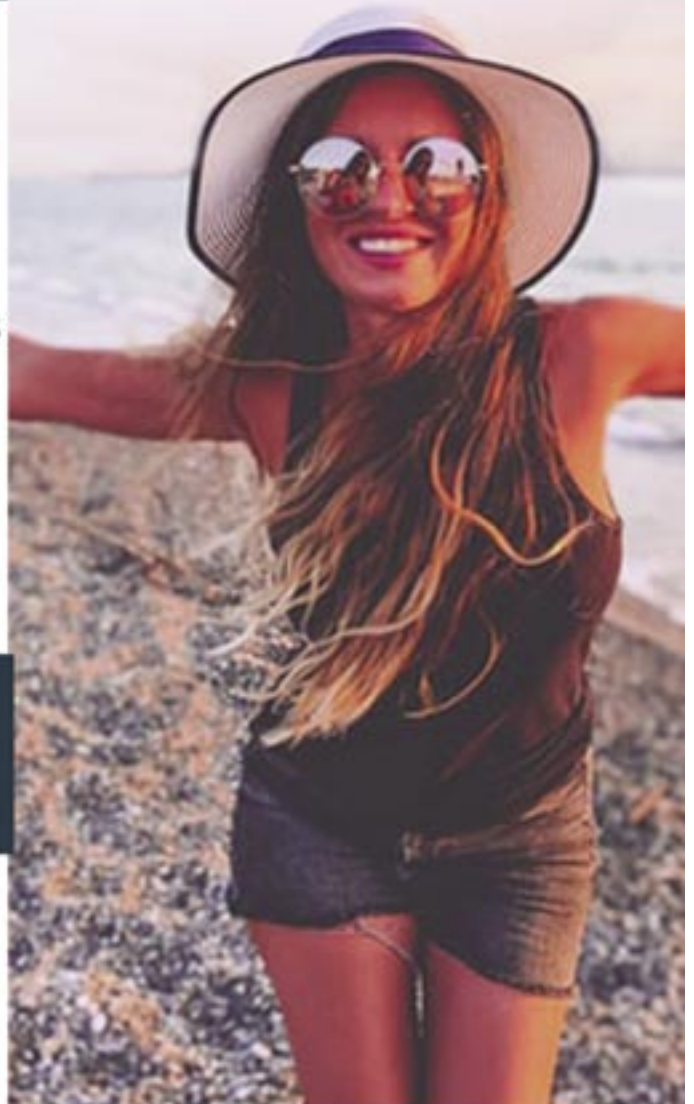
