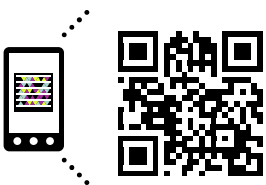

Former Fairhaven School Dept employee embezzles \$100+K

Christine Mitchell, 55, the former Business Office Manager of the Fairhaven Public Schools, pleaded guilty last Tuesday, 10/19/21, to stealing more than \$100,000 from the school department. According to a press release from the Bristol County District Attorney's Office and court documents, Ms. Mitchell stole \$89,893 from Student Activities funds and Preschool funds, and took \$10,892 in checks written to herself, for a total of \$100,785.

She was sentenced by Judge Patrick Malone to two years in the Bristol County House of Corrections, but due to her serious medical condition, the judge suspended the sentence for five years, which means she will be on supervised probation for five years. She must also pay \$1,000 in restitution, which is the amount of the school department's insurance deductible.

"She deliberately went around the systems that she was entrusted to uphold," said Superintendent of Schools Tara Kohler in a phone interview. Ms. Kohler said that Ms. Mitchell was a trusted member of the team, "But she definitely created the scheme to go around the system to steal cash from student activities accounts."

Ms. Mitchell worked in the public schools for 15 years. In 2018 she took an unexpected

medical leave, and discrepancies were found in her absence. When she returned, school officials confronted her. She would not provide explanations, but handed over a resignation letter that ended in "I'm so sorry," according to the DA's press release.

A forensic audit showed she stole \$89,893 from student activities accounts and the preschool fund from 2015 to 2018, and also wrote unauthorized checks to herself in 2011 to 2012. To steal from the activities accounts, Ms. Mitchell received checks and cash but only deposited the checks. She then manipulated internal documents to cover up the theft.

"She really knew the system so well that she had people come around and deal with her directly and that's how she was able to do it," said Ms. Kohler.

In a written statement, Ms. Kohler, said the conviction "brings an end to a difficult chapter for the Fairhaven Public School District."

The ruling affirms that Ms. Mitchell "knowingly stole funds intended to provide programs and services for the students of this town," she said. "We are grateful to the Bristol County District Attorney and the New Bedford District Court for bringing this matter to a fair conclusion."

According to court documents, Ms. Mitchell was able to write checks to herself because

then-Business Manager Paul Kitchen signed blank checks.

In a police interview on 4/26/19, Mr. Kitchen told Detective Janis Guerreiro that there was no stamp with his signature on it, that he did not have any knowledge of checks written out to Ms. Mitchell, but the checks did have his signature.

"Kitchen believed this was because he put too much faith into her," reads the report. "Kitchen said that he had signed blank checks for Christine so that she would have them in his absence as he would take family vacations and other leaves of absence."

Mr. Kitchen told Det. Guerreiro there was no reason for Ms. Mitchell to receive any money other than her paycheck.

Checks written out to Ms. Mitchell totaled \$19,865.20 according to the forensic report by Melanson Heath Accountants and Auditors.

According to the DA's press release, consideration was given for Ms. Mitchell's health due to the seriousness of her condition.

"The defense argued that a jail sentence was effectively a death sentence based on her current state of health," reads the press release. "Assistant District Attorney Madalyn Fairbanks argued that years of deception and theft warranted jail time, but a shorter period was recommended in light of the defendant's health issues."

Selectboard chooses Steve Riley for BPW opening

The Fairhaven Select Board had three candidates to choose from to fill an opening on the Board of Public Works, and decided to go with former BPW member Steve Riley, who was also recommended by BPW members. The appointment is only until April, 2022, when it will be on the ballot and the person will have to run for election to keep the seat.

Al Martin, who ran for the office twice, once tying with Robert "Hoppy" Hobson, and once losing to Frank Coelho, told the board that he was an Army veteran and was truck driver with the BPW, retiring a few years ago.

He said he knows a lot about what's going on and watched a lot of board meetings in his day as shop steward.

"I'm retired. I've got nothing else to do," said Mr. Martin. "It'll keep me out of trouble."

He told the board he would run in April if appointed.

Mr. Riley touted his nine years on the board. He said he retired three

years ago and wants to get back "serving the town."

He said he could "walk seamlessly into the position."

He noted that he served with two of the current board members and he and Mr. Hobson were on the board that hired public works superintendent Vinnie Furtado, who still holds the position.

Mr. Riley did note that he was unlikely to run for the position in April because he is also a deputy shellfish warden and he cannot hold both positions simultaneously. That is a seasonal position in the summer.

Louis Dutton told the board that is the Superintendent of Water and Sewer in Braintree. He moved to Fairhaven five years ago.

"I absolutely love it here," said Mr. Dutton, adding he has wanted to give back for a long time. "I feel this is right in my skill set."

He said he tried twice before when there were vacancies, but did not succeed. He would run in April.

BPW Chairperson Brian Wotton addressed the Select Board saying that Mr. Coelho, who resigned for

health reasons is "adamant" about getting the right person to replace him.

"The next six months are critical," said Mr. Wotton, adding that all three candidates are "phenomenal."

He said the board was recommending Mr. Riley because he most likely will not run in April. It means they will have an experienced person and then the election will choose a new person, which is the normal schedule.

"I don't have time to train up and bring a new member up to speed," said Mr. Wotton, adding he needs someone who can make a "educated decisions. "I'm hiring for six months."

BPW members Marcus Ferro and Mr. Hobson also addressed the board and voiced their support for Mr. Riley.

The board voted unanimously to appoint Mr. Riley to the position.

"Steve," said Harbormaster Timothy Cox, "I really need you next year, so..."

In another matter, BPW Superintendent Vinnie Furtado also briefed

Boil water order lifted

The boil water order for Fairhaven that was put in place on 10/7, has been lifted. The Board of Public Works sent out an alert on 10/23 saying “after satisfying the State’s sampling requirements, the boil water order has been lifted.”

An explanation on the website states that the September incident and the October incident were related to a “breach” in the well casing of the Tinkham Lane Well eight feet below the surface. The breach

“was detected via investigatory camera work and repaired.”

The town will continue to sample and will add sample days to its “already aggressive schedule to ensure that the drinking water remains safe. Also, chlorination and flushing will continue for an extended period of time per the Department of Environmental Protection,” reads the statement.

The town will continue to chlorinate and flush water for an

“extended period of time” as ordered by the DEP.

Residents are also advised to flush their lines and have filters replaced.

“We sincerely appreciated everyone’s patience and understanding,” reads the statement.

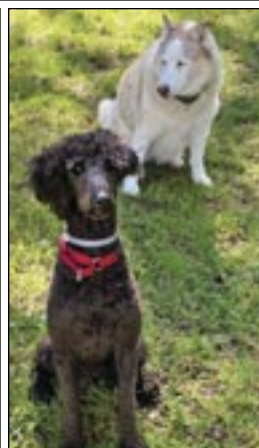
Coach gets shower after big win for FHS

3 cups chicken stock
1/4 cup heavy whipping cream
1/4 teaspoon ground nutmeg
1/2 teaspoon ground sage
1 1/2 teaspoons salt
4 tablespoons sour cream

Preheat oven to 400°.

Cut pumpkins in half and scoop out seeds.

Spray a cookie sheet with non-stick cooking spray. Place pumpkins, flesh side down on the cookie sheet and roast until soft to the touch, about 45 minutes. Remove pumpkins from oven and let cool. Once pumpkins are cool scrape flesh from skins into a food processor. Discard skins.

Add chicken stock to the pumpkin and puree. Pour soup into a large saucepan and bring to a simmer over medium heat. Stir in cream, nutmeg, sage and salt. Mix well and remove from heat. Serve garnished with a dollop of sour cream

A joint effort of the Health Department/Board of Health and the Board of Public Works, the day allowed Fairhaven residents to clean out their sheds, basements, and houses of pesticides, harsh cleaners, oil based paints and stains, fertilizers and batteries.

Health Agent Dave Flaherty and board of Health Chair Peter DeTerra both said the cars were lined up all along Arsene Street straight out to Route 6 by 7:30 a.m.

"It's going really, really well," said Mr. Flaherty at about 10 a.m.

He said it was no surprise that it would be so busy since

last year's day was canceled due to the pandemic.

Denise from MXI, the company collecting the waste for disposal and/or recycling/reuse, said they were mostly seeing oil and oil-based paints.

"Nothing too weird," she said.

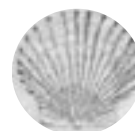

the board on the contaminated water situation. Fairhaven was the last town to be allowed to life its boil water order because it is geographically the farthest from the plant.

Mr. Furtado told the board that the Mattapoissett River Valley Water District, which includes Marion, Mattapoissett, and Rochester, has 12 wells that feed into the water plant. Four are owned by Fairhaven.

The district has never had to disinfect water from the wells because the water is of good quality.

He reviewed the problems with the sampling from the September incident and the October incident.

The second incident was widespread, affecting 75% of the town, he told the board, whereas the September incident involved a single sample.

The district found a breach in the well casing and repaired it. The plant will, however, continue to disinfect the water with chlorine, and the town will continue to flush hydrants.

Mr. Furtado also told the board that the plant is due for an upgrade, and the district is hoping to be able to add "permanent disinfection." He said he would like to see it be a non-chemical option, such as ultraviolet light.

Acting Town Clerk Linda Fredette also addressed the board, explaining that the precinct map has a small change due to the national census results. She noted that the national numbers are "much higher" than her local numbers because census takers go door to door, but she relies on people mailing in their annual census forms.

It is one block that includes Atlas Street and Allen Street, changing some houses from precinct one to precinct four.

"Previously the line for Precinct 4 began on the east side of Atlas Street between Church and Farmfield Streets," wrote Ms. Fredette in a follow-up email to clarify. "Now it begins on the east side of Pleasant Street and now includes all of Atlas Street and Allen Street."

Ms. Fredette told the board that the number of houses is less than 50 and each household will be notified their new polling location. The individual addresses will not be available until the state approves the documents.

The board voted to sign the documents to send to the state.

In other business, the board held a public hearing for a liquor license transfer from the former Ebb Tide, 47 Middle Street, to "Bar on Middle." Lars Vinjerid II, who owns the Ice House, Fathoms, and Fleet Fisheries, has bought the property.

Attorney John Markey, representing the Bar on Middle, said there is no change in location for the

license. The owner is upgrading the building they are working with the Fire Department and Building Department to get the building operational.

The license will be transferred to Bar Manager Pedro Nunes, who currently works for Mr. Vinjerid in another capacity.

Mr. Markey said he was asking the board to forward the application to the ABCC in Boston not to expedite matters, expecting that by the time it is approved, the renovations to the building will be completed.

The board approved the application with the stipulation that it will not be released until the fire department and building department sign off on the building upgrades.

The board also approved a request by Blue Stream Shellfish LLC, which abuts Hoppy's Landing, to run a feed for electricity from Hoppy's Landing.

A representative Blue Stream said the company has been waiting for Eversource to provide electrical service to the property. The company wants to move its operation from across the street to the property it owns at 53 Goulart Memorial Drive.

The company will assume all costs of installation and removal, and will pay for all electricity, including at Hoppy's Landing, while they are tapped in.

Harbormaster Timothy Cox told the board that the Marine Resources Committee supported the proposal.

The Select Board voted unanimously to approve the proposal for six months, with a six month extension.

Five-seat Select Board legislation is on governor's desk

Fairhaven's bid to change the Select Board from three to five members is very close to being a done deal. The Mass. Senate and House have both passed the legislation necessary to make it happen. On 10/21/21, the Senate passed the bill, according to a statement by Sen. Mark Montigny's office.

Town Meeting voted in June to make the change. Both chambers of the state legislature then had to pass the bill, and the governor needs to sign it.

"We're very happy to get this bill

through the Senate in less than four days," said Senator Montigny. "This immediate action ensures that we remain on track to carry out this historic change in time for the next election."

According to Rep. William Straus's office, the bill is now with the governor for his signature.

"I am pleased with the House and Senate final passage today of the bill to expand the Fairhaven select board from three to five members," said Rep. Straus in a statement. "This was initiated at the local level by Town Meeting and I was happy to expedite

the necessary state approval."

Under the terms of the bill, three members will be elected at the first annual town election following the effective date of the legislation. The candidate receiving the highest number of votes shall serve a three-year term. The candidate receiving the second highest number of votes shall serve a two-year term, and the candidate receiving the third highest number of cotes shall serve a one-year term. After this initial election, successors shall be elected for terms of three years, ensuring staggered seats on the board.

BPW discusses Cherrystone Road sewer connections

At its meeting on Monday 10/18 the Fairhaven Board of Public Works conducted interviews for a Principal Clerk in the Sewer Department, and met with owners of land on Cherrystone Road about tying into sewer.

BPW Superintendent Vinnie Furtado informed that board that current clerk would be retiring in December, and eight people applied for the position. Two finalists were chosen to be interviewed by the board.

Gabrielle Almeida told the board that she currently works as a clerk in Mattapoisett assisting the Board of Health and Building Departments, but the position is not full time. Ms. Almeida said she is looking for a full time, long-term position.

She said she also has experience with permitting, and writing minutes.

BPW Vice-Chairperson Robert "Hoppy" Hobson said that Ms. Almeida seemed very qualified and noted she is a Fairhaven resident.

Ms. Almeida said she has lived in Fairhaven for four years and grew up in Mattapoisett.

The board then interview Sharon Mills, who said she has lived in Fairhaven her

whole life. She said she was looking to better invest her future years.

Board member Marcus Ferro asked if she would want to be in this position long-term.

Ms. Mills said she sees herself working in the position for a long time.

Board member Cameron Durant asked if she had technical skills with Microsoft Office Suite. She responded that she has experience with a lot of different office programs.

Mr. Hobson said Ms. Mills is qualified like the other candidate and it would be a hard decision. He noted that Ms. Mills has been with her current company for a long time.

Both candidates were dismissed from the meeting and at the end of the meeting the board revisited the discussion.

Mr. Hobson said he thought he would choose Ms. Mills even though both are highly qualified. Mr. Hobson said Ms. Mills has a history of staying with her job for many years.

Mr. Durant agreed that both candidates were great, but said that Ms. Almeida was the top choice for the hiring committee.

Mr. Furtado said both candidates would do amazing, but Ms. Almeida has

the municipal experience and was the only candidate to pass an Excel Spreadsheet test.

Mr. Hobson made a motion to hire Ms. Mills. The motion was not seconded.

Mr. Durant made a motion to hire Ms. Almeida, and the vote passed 3-1 with Mr. Hobson voting against.

In another matter the board met with John Kalife and his wife Danielle about lots 313 and 315 that they own on Cherrystone Road.

Mr. Kalife said that they are hoping to build a home on those lots and want to connect their property to the sewer.

He told the board that he has documents from the 1990s that show that the previous owner went through all the steps to get a sewer stub to tie into the sewer, but never actually built a house on the property.

Mr. Kalife said in the 1990s the previous owner got a permit to build on the land and went to the Board of Health to get permission to connect to the sewer, which was approved. He said he had all the documentation to prove that a sewer stub was approved.

BPW Chairperson Brian Wotton asked if they know if the sewer stub was ever

Project Manager Brian Pawlowic said workers were sorting the materials according to how flammable they were. Oil based liquids and gas will be burned or will be processed to remove the ethanol which will be burned for heat. Pesticides will be disposed of. Cleaners are neutralized and disposed of.

"Wherever we can, we try to recycle s much as we can," said Mr. Pawlowic.

Nancy Alves said she mostly had household cleaners to dispose of, some old bug sprays and garden chemicals, that came from her basement.

"I'm very, very, very glad they are having this," said Ms. Alves, noting it had been "a few years" since she had disposed of hazardous waste.

Fernando Lemos said he cleaned out his basement, mostly disposing of

Mr. Kalife said they do not know.

Mr. Wotton said that they will do the best they can to help, but they need to find out if there is a sewer stub there, and noted they had a similar issue with another lot on Cherrystone, but that lot did not have a stub.

Mr. Durant said it was different from the other property because that property had nothing. Mr. Durant said if they can find documentation of a betterment fee being paid or find out if there is a stub or pipe there that would help.

Board of Health member Mike Ristuccia was in attendance at the meeting and asked to speak.

He said he was not there representing the BOH, but that he did have knowledge about the property's history with the BOH.

Mr. Ristuccia said that since the 1990's the Board of Health has been in charge of approving properties to be tied into the sewer and the BPW is in charge of granting the properties permission to dig into the street,

He said they were not there to ask for permission for a sewer stub, they were there asking for permission to dig in the street because the Board of Health

already authorized that property to tie into the sewer.

"You're here for the Board of Health," Mr. Hobson said. "You're speaking for the Board of Health."

Mr. Ristuccia reiterated that he was not there representing the Board of Health. He said he had knowledge because he is on the BOH and because he used to be on the BPW and he knows the distinctions between the two. He said he was just there to read the facts from the Board of Health documents.

Mr. Hobson said he would like a copy of the rules and laws from the Board of Health

Mr. Ristuccia explained that the Board of Health approved of the sewer tie in to the previous owner back in the 1990s and the owner at the time went through the whole process to get everything approved.

The health agent was Patricia Fowle who retired in 2015. Mr. Ristuccia said Ms. Fowle left very detailed notes for future employees and left a list of addresses that were allowed to tie into the sewer and addresses that were not allowed according to the DEP agreement.

Mr. Hobson asked if since 1998 there has been a sewer stub there that has not been used.

Mr. Ristuccia said that a sewer stub

was approved in 1998 so there should be one there. Mr. Ristuccia said either way it is irrelevant because the sewer stub was approved.

Mr. Wotton said he wanted to table this discussion and request that Mr. Kalife and Mr. Ristuccia send the board all the documentation so the board can review it and revisit the matter.

Mr. Hobson also suggested they get an opinion from Town Counsel on the matter.

Former BOH agent Ms. Fowle joined the meeting via zoom and confirmed that she did all that work for the property in the 1990s and Town Council was involved then. Ms. Fowle also said she wrote the letter with the approved addresses for sewer tie in and these lots on Cherrystone were approved.

Ms. Fowle said it was the last property approved under that DEP parcel and whether the stub was actually put in she does not know.

Ms. Fowle offered to attend the next BPW meeting when they revisit the conversation about the property.

A motion was made to table this issue until the board reviews all the documentation and gets advice from Town Counsel. The motion passed unanimously.

Ms. Fowle did not disclose that she is Mr. Kalife's aunt.
