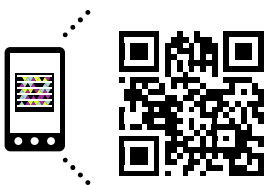

# Fairhaven moving along with TA search; five-member SB

At its meeting on Monday, 11/8/21, the Fairhaven Select Board discussed the Town Administrator search, saying they were on track to interview candidates within the next two to three weeks, and hopefully hire someone who could start as soon as mid-December. The board also announced that the legislation changing the board to a five-member body has been signed by the governor.

Select Board chairperson Bob Espindola told the board that the Collins Center informed the board that the screening committee has chosen finalists for the board to interview for the Town Administrator position. The Collins Center is still conducting background checks on the candidates, but should be ready with the names soon. He said the board would probably need to set up a special meeting for the interviews.

Mr. Espindola thanked screening committee members by name for their work.

SB member Stasia Powers said it

was a “good group of people,” adding, “Well done.”

SB member Keith Silvia recused himself and left the room for the discussion due to a conflict of interest as his wife is the Council on Aging Director and the TA is her direct supervisor.

In another matter, the board approved the Seasonal Population Increase Estimation Form to be sent to the Alcoholic Beverages Control Commission. Attorney John Markey spoke to the board, explaining how he estimated the increase in seasonal population, using the 2010 census and information from the two hotels and one B&B. Based on that information, he estimated a population increase of 1,570.

The form will be submitted with the annual filing to the ABCC. It will allow the Select Board to add seasonal liquor licenses. Filing the form does not automatically grant the licenses, it just gives the town the option to do so.

Mr. Markey said the seasonal licenses will not affect the number of

marijuana facilities allowed because that is based on package stores.

The board also discussed next steps for the Broadband Committee’s work to get a town owned fiber optic system in town.

A pilot project would be first, with three access buildings and up to 100 homes volunteering to test out the system. The final system would be six stations to be able to provide service to every home in town. The consultant is in the process of identifying town owned buildings and properties that are suitable for the project.

The whole project would cost \$21 million, but costs to individual home owners would depend on how many people opt into the system. The plan is to get a private entity to build out the system.

Mr. Espindola said the service would still be cheaper than the currently available internet access in Fairhaven, and it would be much faster. Estimated cost per household is about \$4,000, that could be spread out over 10 years.

## Millicent Drops Most Late Fines

The Millicent Library is pleased to announce that we have dropped late fines for most library materials. We have also eliminated outstanding late fines for most materials. Our vision is to provide access to community resources, knowledge, heritage, and culture.

By eliminating most fines, we are removing barriers to access.

Public libraries play a vital role in the development of early literacy skills, bridging the digital divide, and providing access to library materials and services our patrons may not have otherwise. Research has shown that late fines are not an effective

means of promoting the return of books, and in some cases may actually work against that goal.

The Millicent Library is joining a growing number of libraries that have eliminated fines to expand access to library services.

Mr. Espindola also told the board that the town was officially notified that the governor signed the legislation changing the SB from three to five members. He also said Acting Town Clerk Linda Fredette informed the board that the change can take place for the April election. She submitted a list of questions and answers explaining the process.

In April three seats will be up for election: the seat that is expiring in 2022 and the two new seats.

The new expiration dates will be determined by number of votes. The person with the most votes will receive a three-year term, the second a two-year term, the third a one-year term. After that all seats on the board will have three year terms.

At the special town meeting in February, an article will be submitted to allocate funds for the two new positions.

The board acknowledged the work of state Sen. Mark Montigny and state Rep. William Straus in pushing the legislation through so quickly in the legislature; and town moderator Mark

Sylvia who also wrote and worked on behalf of the town.

Acting Town Administrator Wendy Graves told the board that town officials had a meeting with state Rep. William Straus to discuss federal money expected to filter down to the municipalities. Ms. Graves said the four major areas of grant money the town will most likely pursue are upgrades to both water and sewer, the project at Union Wharf, and town owned broadband.

Select Board chairperson Bob Espindola said that Rep. Straus gave concrete advice on how to structure a grant application to maximize the town's chances of winning a grant. Mr. Espindola said the process is "extremely competitive" despite the amount of money available.

The board also briefly discussed inquiries by residents who had damage to cars and property by town trees that fell on their property during the last storm. Mr. Espindola explained that even though it is a town tree, if it falls on private property, the property owner is

responsible for damage. Ms. Graves said residents can still send a claim to her office and they will forward to the insurance company for a determination on liability.

The board also voted to support the Polar Plunge on January 1, 2022. Organizers are keeping the event low key, eliminating the music and other activities that encourage lingering on the beach. Participation is still encouraged for the plunge, which will take place at 10 a.m. on 1/1/22, at Fort Phoenix.

In other business:

- The board set a public hearing date to discuss the 61A property at 732 Sciticut Neck Road for the next meeting on 11/22. The board is not required to publish another legal notice because it is a continuation.
- Set February 15, 2022 for a special Town Meeting, providing the town moderator agrees with the date. Articles would have to be submitted by 1/16.
- Voted to send a thank-you letter to the town of Franklin for mutual aid rendered during the last storm.



Add olive oil to a large stockpot or dutch oven over medium-high heat. Cook onion for 5 mins until tender. Add ground beef and cook until browned while breaking apart with a wooden spoon.

Add chili powder, cumin, sugar, tomato paste, garlic powder, salt, pepper, and cayenne, if using. Stir until the spices are fragrant and the beef is well-coated.

Add broth, diced tomatoes with broth, drained beans, and tomato sauce.

Bring contents to a boil, then reduce heat to medium-low. Gently simmer for 20-25 minutes uncovered, stirring every so often. Serve hot.

# Acushnet Board of Health hears from neighbors on PJK

The Acushnet Board of Health met with about 30 neighbors of the PJ Keating Company quarry and asphalt plant on Saturday, 11/6/21, at the Senior Center, and heard about a host of complaints, including dust, odor, and noise that neighbors say have been getting worse.

A change in the bylaw governing the property several years ago allowed the company to move the asphalt operation to the front of the property, closer to residences. The new asphalt plant only started operating about a month ago, and complaints have increased since then.

One of the changes allows liquid asphalt to be stored in large tanks that now can be seen from the road. The town halted that part of the operation, so the company is only allowed to truck in the amount of asphalt it will use each day.

BOH chairperson Thomas Fortin opened the meeting and noted that the town is in litigation with PJK, so some questions, may not be answered in full.

Diane Abrams began the discussion, saying that on that very morning the smell was so bad that her nose was burning. She said people are worried that taxes will go up if they stop operation of the company, but her granddaughter's health is worth more than \$100 or \$200 more in taxes.

"This is still America, and we still have a voice," said Ms. Abrams.

She urged the "town fathers" to do something to stop the company, adding that PJK has millions of dollars so they feel they can do what they want, even if it is not legal.

Town Counsel Jeffrey Blake urged her and others in the room to use the portal on the town's website to report

violations.

"The town will take every complaint you have seriously, very seriously," said Mr. Blake.

Linda Skapik said her asthma had been kicking up again. She said this summer, when the plant was not operating, her asthma was not acting up. She also said a group of neighbors online had the same complaints.

Ms. Skapik and several other residents referenced the lawsuits between the town and PJK. Mr. Blake assured residents that the lawsuits do not prohibit the BOH from acting on any health/nuisance complaints related to the operation of the plant. He said the company has a right to due process, so the court cases are proceeding. He also said the asphalt plant only "fired up" a month ago so none of the litigation involves it.

Several residents complained that

their cars were damaged from tar. Mr. Blake told them that is a matter between them and PJK, not the town.

Kevin Smith said he has been fighting and going to meetings for more than 20 years. Sometimes, he said, no one was at the meetings besides him and board members. He said people need to get involved and stay involved.

Mr. Smith asked about air quality monitors. He said the people who work at PJK or visit there are in their vehicles, but the residents are exposed to the bad air. He said the state should have taken air quality samples while the plant was not in operation to get a benchmark.

"DEP [Department of Environmental Protection] has left us hanging," said Mr. Smith.

Mr. Blake said there are air monitoring stations on the property.

PJK is also required to spray piles to keep the dust down, and wheel wash trucks.

Mr. Smith said it is not mandatory, and the wheels on the trucks clearly have not been washed. Basically, he said, PJK has said, "screw all you neighbors," because it is a big company, and can do what it wants. He said the company has never been honest with them before, so it cannot be trusted now.

Cheryl Hall said that PJK reported there was no silica in the particles, prompting laughter from the residents. She said her gutters are clogged with silica dust. This was the first summer she did not have to run her pool 24 hours a day, because the plant was shut down.

"I am frustrated," said Ms. Hall, adding she did not expect them to shut down. "But I expect them to be good neighbors."

She noted that when the plans for the new plant were revealed, the new equipment promised to make the operation "odor free," prompting more laughter from the residents.

That was what they proposed, she said, and they proved in less than a month that they will not work collaboratively.

Doug Thomas said that the "parade" of trucks started at 5:15 a.m., which is a violation of the company's hours of operation.

One resident said that a puff of smoke or steam can often be seen hanging over the plant.

Residents also asked about DEP and questioned whether or not the agency was taking the matter seriously.

Mr. Blake noted that it's a "by-right" use of the property. DEP had to

# Fairhaven welcomes four new firefighters, promotes Burr

Fairhaven welcomed two full time firefighters and two call firefighters to the ranks on Monday, 11/8/21, with the official swearing in during the Select Board meeting. The Department also promoted Chauncey Burr to Lieutenant.

Fire Chief Todd Correia said the department had lost 38 years of experience due to retirements in the last five years. He said 75% of the department has less than five years of experience. It is important, he said, that they hire and promote from within to educate and train new firefighters.

The department has seen “historic numbers in run volumes,” in the past year, said Chief Correia, so it is “important and imperative” to find and hire the best qualified candidates.

He introduced Chauncey Burr, saying he joined the department in 1993 as a call firefighter, and went full time in 1995, the same time as Chief Correia.

“He doesn’t always see eye to eye with me,” said Chief Correia, adding it was “advantageous” to him because it helped him see different sides and opinions.

He said Mr. Burr has “vast experience and a lot of knowledge behind him,” is an excellent paramedic and a born leader.

Acting Town Clerk Linda Fredette swore in Lt. Burr, and then his father pinned on his new badge.

Lt. Burr thanked his dad for not stabbing him in the chest, and noted his father was a call firefighter in Fairhaven.

Lt. Burr also thanked his wife, saying “without her direction, this wouldn’t happen.”

Chief Correia introduced the new firefighters: Todd Sexton, Spencer Espinola, Heather Lopes, Matthew Foster.

Mr. Sexton is a firefighter in Carver and has a background in construction. He will attend the fire academy in December of this year and

paramedic school in March, 2022. He was sworn in as a full time firefighter.

Spencer Espinola was also sworn in as a full time firefighter. He works in the New Bedford fire department and for Brewster EMS. He will attend the fire academy in March of 2022.

Heather Lopes and Matthew Foster were sworn in as call firefighters. Both graduated from the academy for call firefighters this past Monday.

Ms. Lopes is the daughter of retired police officer Tony Lopes; Mr. Foster is the nephew of Sgt. Foster of the police department.

issue the permits as long as the company complies with regulations.

DEP is the enforcement agency for the use of the property. The BOH is the enforcement agency for "nuisance" issues, such as odor and noise.

He assured residents that DEP is frequently updated on complaints.

"We're keeping this on the front burner," said Mr. Blake.

Allan Baker told the board that he has seen stone dust in the woods and in places where the trucks never unload, so it is clearly from airborne dust.

Deborah Polchlopek told the board that while other people are outside enjoying the "crisp, fall air," PJK's neighbors are afraid to go outside

The horrible odor smells like burning rubber, oil and "God only knows" what chemicals are in the air, she said, adding that the smell is "lingering" and "traveling," prompting complaints from other parts of town.

Recently, asphalt has joined the dust in yards, in pools, on children's toys outside, she said. The company has blamed the asphalt and odor on nearby repair work, but never identified where.

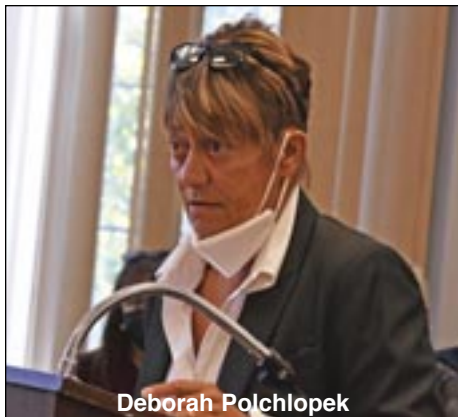
"They are responsible for the invasion of these toxic odors," said Ms. Polchlopek. "We all know it."

They are neglectful and are ruining "our beautiful town," she said. "It's a shame. It really is. It's a shame what's taking place here. I'm disgusted."

She asked if they knew for sure that it is asphalt in the air and how it can be monitored.

"We don't know what we're smelling. All we know is, it's horrible. My throat's burning, my eyes are burning," said Ms. Polchlopek. "We have residents becoming sick because of it. I'm afraid to go outside. I'm beginning to lose my voice."

Conservation Agent Pat Hannon

answered that they are working with an air quality expert to come up with a plan to detect volatile compounds.

Roland Pepin agreed with Ms. Polchlopek that the odor is traveling. He said it was like someone was burning electrical wire in his back yard, but it was a half mile away. He said he has a pool and his grandchildren swim in it every summer.

"I'm fearful of their life because of this odor," said Mr. Pepin.

Doug Thomas told the board that the company "literally rubbed this community's face in it" when they moved the asphalt plant to the front of the property.

"They've created the ultimate monster," said Mr. Thomas, adding

that they have not been good neighbors. Trucks lined up at 5 a.m. that very morning he said. "This is like a punch in the gut."

"We're fed up," said Mr. Thomas. "We're fed up as residents of this community. And we want action."

Mr. Blake asked Mr. Thomas to use the portal to report the 5 a.m. trucks because it was news to the town, as trucks are not supposed to be going into the plant that early.

The two went back and forth about the building permit and other permits for use, and whether they were acquired properly or not.

"This is a toxic business," said Mr. Thomas. "They're destroying this community."

Mr. Blake noted that the plant did not operate all summer because DEP did not accept the company's assertion that the changes were minor. DEP finally issued the permit just about three weeks before the meeting and already there were numerous complaints. He reiterated that it is important for residents to

lodge their complaints so the BOH has documentation to take action on the nuisance complaints, and to send to DEP for possible action on the permit.

Mr. Thomas said the company has not shown a history of playing by the rules.

"We should not have to ask them to do their jobs," he said.

Mr. Smith also noted that the company is not locally owned, so owners do not care about the local community. He said the community needs to stick together and support the BOH in their efforts to hold the company accountable.

"If we self destruct, they win," said Mr. Smith, adding that things will only get worse if the community does not keep at it. "We have to stick together and stick to our guns and support the Board of Health and Board of Selectmen."

He said people need to show up at the meetings.

The board also discussed the change in the bylaw that allowed the expanded use of the property. Town Meeting struggles for a quorum each year, they noted, so a small number of people approved the new bylaw with the required 2/3 vote.

"The odor is real," said Chuck Schestak, noting that PJK representatives have called him a liar by denying the odor exists at all, a charge also made by other neighbors. "I do not want to be here today. No one does. We just want to live our normal lives."

Neighbors also told the board that they felt they were left in the dark and not notified about meetings or updated on any action the town is taking. Mr. Fortin said the BOH would post weekly updates on the town's website and find other means to keep residents updated.

# BPW to allow tie-in at one of the Cherrystone props in question

At its meeting on Monday 11/1 the Fairhaven Board of Public Works conducted interviews for a Special Motor Equipment Operator for the Highway Department, and met with owners of land on Cherrystone Road again to discuss allowing a sewer stub on a new house.

BPW Chairperson Brian Wotton first started the meeting by welcoming the newest board member Steve Riley back to the BPW board. Mr. Riley was on the board years ago and is back to fill the vacancy left by Frank Coelho.

The board first interviewed Matthew Girouard for Special Motor Equipment Operator for the Highway Department. He explained that he has been working in the Fairhaven Highway Department for three years, and has all the licenses needed for the HMEO job, and he knows how to run almost all the equipment

BPW Superintendent Vinnie Furtado explained to the board that the other candidate being interviewed, James Lawrence, was the most senior employee, but Mr. Girouard meets all the qualifications and Mr. Lawrence does not.

Mr. Furtado said that the contract says to hire the most senior, qualified employee.

BPW Vice-Chairperson Robert "Hoppy" Hobson asked if Mr. Girouard has his backhoe license.

Mr. Furtado said that Mr. Girouard has all of his licenses, but has not run all the equipment yet.

Mr. Girouard said he has had his licenses for over a year and it only took him a couple of months to obtain them.

"You are the most qualified, but not the most senior," Mr. Wotton said. "It says to hire the most senior qualified person... we are split either way."

Mr. Lawrence told the board he has been working for the Highway Department for seven years and has one of the licenses needed for the job. He said knows how to use most of the equipment, he wants the chance to move up, and he wants to be in the department for the duration.

Mr. Wotton explained to him that he is not a shoe-in for the position because he does not have all the licenses.

Mr. Lawrence said he paid the \$150 to take the license test but he is wait-

ing to hear back to schedule the date.

Board member Marcus Ferro asked what licenses Mr. Lawrence needs.

Mr. Lawrence said he needs two licenses and he already paid to take the tests. He said he will know the test date within the week and would know if he passed the tests a few hours after.

Mr. Wotton said that employees need to be prepared when job openings come up. He said if you want a job you should go and get your licenses so you are ready when a job opening comes up.

Board member Cameron Durant suggested that they go with the recommendation of the Highway Superintendent John Charbonneau, who recommended Mr. Girouard for the position because he said he needs the employee to be able to use the equipment immediately; if the

employee does not have the licenses then they cannot use the equipment.

Mr. Furtado explained that they could hire Mr. Lawrence and give him two months to past the tests and if he does not, they could replace him with Mr. Girouard.

Mr. Durant said they could also hire Mr. Girouard as interim while Mr. Lawrence works gets his licenses.

Mr. Hobson made a motion to hire Mr. Lawrence. The motion was not seconded.

Mr. Durant made a motion to hire Mr. Girouard. The motion passed 4-1 with Mr. Hobson voting against it.

"Both are good employees," Mr. Hobson said.

In another matter the board brought back the discussion of granting a sewer stub to lots 313-315 on Cherrystone Road.

At the last meeting the board met with lot owner John Kalife, Board of Health member Mike Ristuccia and retired Board of Health agent Patricia

Fowle. The three of them had a lot of documentation from the previous owners of the lots.

Ms. Fowle explained at the last meeting that Mr. Kalife's property was the last property of 380 properties that were approved for a sewer stub back in the 1990s.

After the last BPW meeting the board requested copies of all the documentation to review and discuss with Town Counsel Tom Crotty.

At the 11/1 meeting Mr. Wotton explained that all the documents were reviewed by the board and Town Counsel and Mr. Crotty verified that the property is the last available sewer stub and has the right to tie into the sewer.

Mr. Furtado explained that they have denied everyone else because no other property has met the criteria.

In his email, Mr. Crotty said in his opinion the property satisfies all the requirements and does not violate the sewer deal they have had with the state since the 1990s.

Mr. Crotty also explained that the Board of Health regulation states that any property that had an existing house or building permit on or before January 28, 1998 is allowed to tie into the sewer system. The documentation of this property from the previous owner proves that a building permit was issued to that owner before the 1998 deadline.

Mr. Wotton said it was clear that Mr. Kalife's property should be allowed to tie into the sewer, but Mr. Wotton said there is no evidence of the betterment fee ever being paid.

Mr. Riley also asked if Mr. Kalife has gotten a building permit yet.

Mr. Kalife said he thought he had to get approved to tie into the sewer before applying for a building permit.

Mr. Riley said he was all for it, but Mr. Kalife needs to make sure he gets a building permit before they start cutting into the road to tie into the sewer.

Mr. Wotton said the board needed to vote to allow Mr. Kalife to dig into the street to tie into the sewer pending receipt of a building permit.

Mr. Hobson said that Mr. Kalife would also have to pay the betterment fee, and expressed his concern that allowing Mr. Kalife to tie into the sewer is going to open a can of

worms. Other residents have asked the board about the same issue, and have been denied.

Mr. Furtado explained that the other residents who appeared before the board have not had the documentation that Mr. Kalife had and have not had the approval of Town Counsel.

The board voted unanimously to

Mr. Furtado said it has been a busy time and all hands have been on deck and he appreciates everyone's efforts.

Mr. Furtado also said the recycling center hours will be extended for the next week with no permit needed to allow residents to dispose of debris, brush, leaves, and branches from the storm.

Our last meeting covered a broad list of topics and projects we are working on regarding town accessibility, including but not limited to: expanded handicap parking at town-sponsored events, purchasing accessibility mats for the town beach, helping to provide access to resources for parents who are advocating for a child with special education needs, organizing a coalition of volunteers to shovel bus stops during and after snowy weather, and re-establishing a working committee to decide on how to make the Tax Collector's office more accessible at Town Hall.

The emergency response best practices we all utilized will only get better as we digest what went right and what could make it better.

I personally want to give thanks to all of the town's departments for coming together so well and working together during a trying time. The Police Department, the Fire Department, the Board of Public Works, and of course my two tree guys who came out at 4:00 a.m. in 25 knots of wind

and driving rain, Mike Lewis and Joey Borges. And as well the residents of Fairhaven deserve credit for their patience and resolve.

I want to in particular thank the Police Dispatchers who were my only contact for the first several hours of the storm and allowed us to react in an efficient way. [Fire Chief] Todd Correia's leadership did an outstanding job of bringing technology and personnel together to really get a unified response moving along at a rapid rate. Becky Vento in the BPW deserves a big shout out for her work and organizational skills as well as Vinny and his entire gang. It was truly all hands on deck.

Everyone really came together and I feel really good about the direction this town's government and administration is going in. We still have a lot work to do. A lot of deadwood needs to be picked up and stumps removed. That will take quite some time.

Lastly I want to publicly acknowledge Brutus Cantoreggi who is the Head of the DPW in Franklin Massachusetts. A call went out to MEMA (Massachusetts Emergency Mutual Aid) and Mr. Cantoreggi and the town of Franklin sent a three-man crew on Thursday and Friday to help get roads open. Thank you Brutus, John, Jim, Brandon, Mike, Vito and Jared.
