Dear Mr. Deterra,

My office has attempted to contact you and left several messages attempting to schedule a meeting to discuss reports made to me that were addressed at the beginning of the Zoning Board of Appeals meeting on August 1, 2023. As stated to the collective Board at the opening of the meeting, it was brought to my attention that there had been chain deliberation, an Open Meeting Law violation in addition to conflict of interest and potential ethics violations posed on some issues coming before the Board.

As a regulatory board it is required that all members act under every aspect of the Open Meeting Law which includes not deliberating outside of meetings on matters to come before the Board. Chain deliberation or speaking with a quorum of members collectively or individually as well as advocating for a specific decision and a vote on an issue that an individual board member has a vested interest in financially, personally or otherwise can lead to that individual being held personally liable.

The reports made to me are very serious and require attention. Please contact my office at 508-979-4023, ext. 2 and schedule a time to meet with me as soon as possible. If I do not hear back from you by Monday, August 21, 2023 regarding this matter it may be necessary to escalate it to the next steps including referring to the Select Board for review and potential action as well as to the State Ethics Commission.
