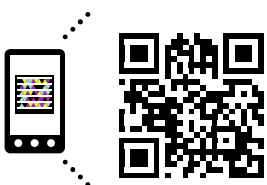

Friends of the Millicent Library invite the public to an Author Talk with Ted Reinstein about his latest book *Before Brooklyn: The Unsung Heroes Who Helped*

*Break Baseball's Color Barrier.*

In the April of 1945, exactly two years before Jackie Robinson broke the color barrier in major-league baseball, liberal Boston City Councilman Izzy Muchnick persuaded the Red Sox to try out three Black players in return for a favorable vote to allow the team to play on Sundays. The try-out, however, was a sham.

This book tells the story of the little-known heroes who fought segregation in baseball, and reminds us that the first Black player in professional baseball was not Jackie Robinson, but Moses Fleetwood Walker in 1884, and that for a time, integrated teams were not that unusual.

# Select Board recognizes those who helped with families

At its meeting on 1/22/24, the Fairhaven Select Board recognized the many people who worked to welcome the unsheltered families that were placed at the Seaport Inn by the state last October. The families have recently been moved to other places. When they first arrived, some protesters gathered outside the Seaport objecting to the program that allows homeless families and immigrants to be placed in hotels at the state's expense.

The town coordinated a response to help the families settle in and find their way around town. Kelly Ochoa formed the "SouthCoast Welcome Corps," a group of volunteers who fund support and services for the families. Church groups, social service groups, private businesses, individuals, and town departments worked together to welcome the families.

Fairhaven Town Administrator Angie Lopes Ellison said it was

"somewhat of a collective" and that Fairhaven Council on Aging Director Martha Reed coordinated the effort.

Ms. Ellison said Fairhaven took a new approach to handling the situation with the families. She said she wanted everyone to know how much the town appreciated and valued their commitment and the level of support they showed in welcoming everyone.

"Fairhaven ended up being a model for a lot of other municipalities because we embraced it and took it on as a positive attribute for our community," said Ms. Ellison.

Ms. Reed told the volunteers there that they did all the work, making her job of coordinating it easy.

"As citizens and as people of good community spirit, our job is to lift people up and all of the groups that were involved really lifted these families in a way that was really unprecedented," said Ms. Reed. "So I appreciate and thank every one of you."

She singled out PACE (People

Acting in Community Endeavors), especially for helping families with MassHealth and WIC applications; Kelly Ochoa for forming SC Welcome, which helped with day to day needs and emergency needs; and the Dawickis of the Northeast Maritime Institute for helping with a variety of things, including use of the van.

"This community really came together and it really made my role very easy to just kind of coordinate the things in place," said Ms. Reed. "I could not have done it without each and every one of you, so thank you."

SB Chairperson Leon Correy read the proclamation which lists many groups to recognize and expresses the "profound gratitude" of the board.

"The exemplary selflessness exhibited by these individuals in aiding over one hundred unsheltered persons, many of whom came to Fairhaven without proper supplies, serves as an inspiring testament to the true spirit of community and compassion, through volunteer funded

# Racist graffiti found in Middle School bathroom

The Fairhaven School Department and Fairhaven Police Department are investigating an incident of racial graffiti at Elizabeth Hastings Middle School. The graffiti, which included the N-word, was found in a boys' bathroom, according to school officials and some parents with students at the school.

According to sources, Principal Kyle J. Alves reportedly visited each classroom with a strong message to students that racist graffiti is not acceptable. A statement from Superintendent Tara Quirk Kohler confirmed the reports.

School Committee Chairperson Colin Veitch also confirmed that an incident occurred.

"It is being investigated by the school administration according to our civil rights policies. The SRO

(School Resource Officer) was also notified," said Mr. Veitch.

Ms. Kohler released a statement saying that the graffiti was discovered on January 17 and included "racist language."

"In accordance with our Civil Rights Policy, an investigation into the incident was opened immediately," she said. "The building Principal has reiterated our expectations to students that when they hear and see this type of behavior, they should report it."

Ms. Kohler wrote that administrators are conducting a school-based investigation and have also referred the incident to the Fairhaven Police Department.

"This type of behavior is unacceptable and does not reflect the values of the Fairhaven Public Schools Community," wrote Ms. Kohler. "Student safety is and will

continue to be our top priority."

In a follow-up interview, Ms. Kohler said that schools do often have graffiti and they always investigate, but only refer it to the police when it crosses a line. In this instance, she said, it was clearly racist, so the school referred it to the police.

She said it was good that students reported the graffiti. She said it was an opportunity for the school to remind students of the rules and to talk about the behavior.

She was happy, she said, that the principal spoke to students.

The town also had an instance of racist graffiti on the Rogers School, which is empty. The words "F\*\*k ni\*\*rs," with the drawing of a penis was scrawled on the wall outside. (See 11/23/23 issue.)

A mural of Henry Huttleston Rogers has been painted in that same spot. (See 12/7/23 and 1/4/24 issues.)

## No Shellfishing

All of Buzzards Bay has been closed to shellfishing due to the excessive rain storm on 1/9 & 1/10. The City of New Bedford emptied more than 40 million gallons of raw sewage into the outer harbor.

In a letter to the coastal communities in the South Coast, the Division of Marine Fisheries said due to the combined sewer overflow discharges from the heavy rainfall, the area will be closed for at least 21 days starting on 1/11. Although that makes Feb. 1 a possible opening date, the letter says the areas will not automatically open. They will have to be examined, so they are closed until further notice.

# Recipe of the Week

## Touchdown Casserole

1 pound ground beef  
 1 teaspoon granulated sugar  
 1 teaspoon salt  
 1 teaspoon garlic salt  
 2 (15-ounce) cans tomato sauce  
 1 (8-ounce) package of egg noodles  
 1 cup sour cream  
 1 (3-oz) pkg cream cheese, softened  
 1 large white onion, diced  
 1/2 cup sharp cheddar cheese, shredded, plus more to taste  
 Preheat oven to 350°. Grease 9x13" casserole dish with butter.

Place a large skillet over medium-high heat. Add the ground beef, stirring to break it up, until brown and crumbly, about 5-7 minutes. Drain the grease from the skillet.

Stir the sugar, the salt, the garlic salt, and the tomato sauce into the browned beef.

Reduce the heat to medium-low and cook for 20 minutes to allow the flavors to blend.

Turn off the heat and let the ground beef mixture cool to room temperature.

Boil the egg noodles in salted water, stirring occasionally until cooked, but firm, about 5 mins.

Drain the liquid using a colander.

In a large bowl, combine the sour cream, the cream cheese, and the diced onion.

Arrange 1/2 of the egg noodles into the bottom of the prepared casserole dish.

Cover the egg noodles with 1/2 of the sour cream mixture. Layer on 1/2 of the ground beef mixture. Repeat the layering until all the ingredients are used.

Top the casserole with the cheddar cheese.

Bake until the cheese has browned and melted, about 25-30 mins.

At its meeting on 1/22, the Acushnet Selectboard recognized former Council on Aging Director Heather Chew and Donna Lake, Emergency Pet Shelter Coordinator, for their service to the town.

Ms. Lake recently resigned from the Office of Emergency Management. And Ms. Chew resigned as COA director.

Ms. Lake was recognized for her contributions as a veterinary technician, ASPCA Responder, and meal provider to seniors

"Her actions and selflessness to help during the COVID-19 Pandemic is of great value," reads the citation that Chairperson Kevin Gaspar read at the meeting.

When the law required that pets also be included in emergency shelters, "Donna worked diligently to formulate the most in-depth plan on the South Coast. Her Humanitarian Efforts are applauded."

Ms. Chew was recognized for her 12 years of "dedicated service to the well-being of senior citizens and all

Residents of the Town of Acushnet Community."

She was also recognized for her efforts during the pandemic, including food programs and vaccination clinics.

Her dedication was "exceptional," reads the citation, "and her Positivity and Advantageous Contributions are Admirable."

The board also voted to hire Lauren Golda as COA Director.

He read from her letter outlining she has a Master's in Healthcare Administration and experience in healthcare management and with geriatrics. She was a nurse's aide as a teenager and decided at a young age to dedicate her career to seniors.

Town Administrator James Kelley said it was unusual to get someone who "fits the job description like glove," but Ms. Golda does.

SB member David Wojnar said he knew Ms. Golda from when his mother was in hospice care.

He got to "see her in action," he said, and the town is "blessed to have someone of this caliber."

Ms. Golda told the board that just being able to express her interest in the position was an honor.

"And I hope I won't let anybody down and I'm really excited to get started," she said.

She told the board she was 18 years old and an Old Colony graduate when she decided the elderly population was where she wanted to be.

"I loved the stories," she said, adding maybe because she was so close to her grandparents growing up.

She said she was excited to be back in Acushnet.

"I'm glad to be back in the community that shaped me into the adult that I am," said Ms. Golda.

# Cigarette butts are biggest and smallest pollutantss

## CB Litter - The biggest and smallest pollutant around

Cigarette butts (CB) are the most littered item in America. They block storm drains and cause pollution to waterways. They accumulate along land mass leading to sediment and erosion. They pose hazards to wildlife while contaminating both the water and the land surrounding it.

Although cigarette sales, according to the (FTC) Federal Trade Commission, have seen a decline of 400 billion individual cigarettes sold in 2001, the disposal of these cigarettes, cigarette butts, and cigarette filters (collectively referred to as CB Litter) is still a major contributor to overall pollution.

- 173.5 billion individual cigarettes were sold in 2022
- Approximately 9.7 billion cigarette butts were discarded improperly
- 4 billion individual CB Litter eventually made it into waterways
- Which equates to 18,456 CB's littered every minute

CB Litter is small and light and is

easily blown from place to place. Meaning, wherever CB Litter begins is almost never where it ends up. Usually areas not common to pedestrian or vehicle traffic, such as; wetlands, under trees and bushes, and waterways.

All land CB Litter is decomposed by mycelium, which is a white or cream colored moldy fungal growth. Unfortunately, this causes Blight, which is a plant disease covering lower stems giving a white-washed appearance to the base of plants, shrubs, and trees.

All water CB Litter leaches out toxic emissions from the cigarette paper and the filters such as; cadmium, lead, aluminum, arsenic, copper and zinc, just to name a few.

Here in the town of Fairhaven, whether CB Litter is on land or in water it has a high potential of contaminating our collective drinking water supplies. Not only impairing our water quality in preserved wetlands, lakes, ponds, streams, and rivers, but contaminating our groundwater which is beneath the surface of our land. The possibility that one day

we may drink this is real, so prevention is key.

It is a great thing that cigarette sales, and tobacco products in general, are on a decline. This helps out further pollution. But today, CB Litter continues to remain a significant pollution problem.

In Fairhaven we all do our part in keeping our wonderful historic town as beautiful as it was since 1812, by striving to keep pollution to its barest minimum. And the health and welfare of the residents directly tie into prevention of the water pollution as well as the land.

With park and beach cleanups coming soon as the warmer months approach, be on the lookout for those in your area clearing up pollution and see first hand how CB Litter affects the biodiversity in Fairhaven.

Water is essential to an abundant life. Not only ours, but all living beings in the town. So let's strive to keep CB Litter out of it.

resources," reads the proclamation.

After a brief recess to take photos, SB member Bob Espindola asked if the town would be able to receive any reimbursement from the state for any staff time that may have been used.

Ms. Ellison said it was mostly volunteer, but she believed the school department was getting some money for the students. She said that the shelter communities are approaching the state to get the hotel taxes applied.

The board also heard from Paul DiGiuseppe, the Director of Planning and Economic Development, who gave an update on the town's efforts to create a 40R district, which would allow for denser housing and mixed retail in certain areas of town.

Mr. DiGiuseppe said they had narrowed the area down to Route 6 and Alden Road.

The zoning in the district would include some building standards, including building heights and setbacks, and new roads.

A working group of town officials and residents has been working on

the proposal for a couple of years.

Attorney Adam J. Costa, of Mead, Talerman & Costa, told the board that the first phase is to come to a consensus on how the district might be developed. He said the working group has come to that and had been "fairly well attended."

"Feedback has been generally positive," said Mr. Costa.

The next phases are the legal draftings and the design.

He said they have a first draft of the zoning. Then it goes to the SB and will require a public hearing. Then the application will be submitted to the state.

The state will review it. If it is in compliance, it will go to Town Meet-

ing for approval. Then back to the state to be in effect.

Mr. Costa and Mr. DiGiuseppe said they hoped to get the measure on the warrant for the May Town Meeting, a tight schedule.

The board will look at the draft at its next meeting and vote on submitting the application.

South Main ends, the intersection at town hall.

Mr. Gaspar said members of the church have asked because the fence keeps getting hit. He said a plow driver went had an accident there in the last storm.

He and DPW director Dan Menard measured it out and got some pricing.

The plan is to put steel guard rails and lights with arrows to let people know the road ends and they have to go left or right, not straight.

Mr. Gaspar said it would cost about \$4,200 and could possibly save somebody's life.

Mr. Wojnar said he was concerned about the aesthetics and asked if they could paint the guard rails, or do something to dress it up. He said other places use planters and other creative methods.

Mr. Gaspar said they will have to coordinate it with fixing the sidewalk so there is no rush, but he would talk to Mr. Menard about possibly painting it.

The board voted to allocate up to \$4500 for the project.

In another matter, the board discussed a possible change in the VFW's restricted music license. The organization is looking for an unrestricted license.

Mr. Gaspar noted that the only

unrestricted license in town is at the Century House. He said it was a good revenue maker, but he was concerned about loud music at late hours in a residential district.

The board decided not to act on it, but to discuss it at the next meeting after getting more details on what the license would actually allow, and what the VFW wants.

The board also discussed six requests for street lights in different parts of town.

SB member Bob Hinckley said one of the requests was because a lot of vehicle break-ins were happening in the neighborhood. He said even the doorbell cameras were no help because it was too dark. Another street was having trouble with dirt bikes and four-wheelers.

"My feeling is people pay an awful lot of money in taxes," said Mr. Wojnar, adding he did not think there would be a "run" on street lights.

Mr. Gaspar said he agreed people pay a lot in taxes but they can't "get crazy and start decorating the town like a Christmas tree."

The board decided to look into the costs of adding street lights, and will address it at a future meeting.

Fire Chief Thomas Farland also addressed the board, looking for support for two Town Meeting articles to replace some

aging communications equipment.

He told the board that the radio repeater on Mendall Road is 30 years old and is also not in the best place. He said the farther away they get from it, the more static they hear, calling it a "bad safety issue for our department and the public."

He said it will cost about \$40,000 for the new equipment and to relocate it to the LNG tower on Peckham Road.

The company worker laughed at him, he said, when he saw the condition of the equipment and how old it is.

The department also needs to replace two alarm receiver boxes. He said they no longer make the parts to repair them. The cost to replace the alarm boxes is about \$150,000.

Mr. Gaspar said he thought Mendall Road was the highest point in town and that is why they put the repeater there.

Chief Farland said it probably was at the time, but now there are cell phone towers that they have access to. He said there is a spot in the base of the tower and on the tower for the Fire Department, they just never used it.

Chief Farland will "fine tune" the numbers to get the articles ready for Town Meeting.

"Thank you for being proactive," said Mr. Gaspar. "God forbid if we lost that communication."

In other business, the board assigned Mr. Gaspar to be the board's representative for contract negotiations with the Department of Public Works.

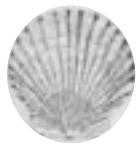

# Select Board race in Fairhaven continues to heat up

Nomination papers for all town-wide elected positions and Town Meeting members are available in Fairhaven.

Five people have now taken out papers for Select Board, with the addition this week of Patrick Carr, who is on the Planning Board and the Zoning Board of Appeals. Mr. Carr recently got in a dust-up with the Select Board over his status on the ZBA. He wanted to be elevated from an alternate member to a full member, but the board appointed Andrew Romano to that seat. Mr. Romano is also a declared candidate for SB.

In addition to Mr. Carr and Mr. Romano, Donna McKenna, Cathy Melanson, and Andrew Saunders have also taken out papers for SB.

Only Mr. Romano had returned papers by press time.

Another addition from last week is Don Collasius, the current Tree Warden, who took out papers for the Board of Public Works.

Barbara Acksen also added her name to the list, taking out papers for Board of Health, a board she has run for several times, winning once for one term.

Candidates seeking to be elected to office need to take out nomination papers from the town clerk's office and return them with the required number of signatures from registered voters.

Town-wide offices require 50 signatures; town meeting requires 10 signatures from the precinct in which you are running.

Select Board has two seats up for election, held by Leon Correy III and

Robert "Bob" Espindola; School Committee has two seats up, held by Donna McKenna and Colin Veitch; Board of Health has one seat held by Kevin Gallagher; Commissioner of Trust Funds has one, held by Colleen Silvia; Board of Public Works has two seats, held by Robert "Hoppy" Hobson and Travis Rapoza; Planning Board has two seats up, held by Jeff Lucas and Jessica Fidalgo; Housing Authority has one seat on the ballot,

intend to run for reelection.

As of press time, four people had taken out papers for the School Committee seats. Colin Veitch took out papers to be reelected to his seat. Nicole Pacheco, Erik Baumann, and Brendalee Smith all took out papers for the full term and the unexpired term on School Committee. They will only be allowed to return papers for one of the seats. By press time, none had returned papers.

In other races the following people took out papers: Jessica Fidalgo and Diane Tomassetti for their seats on the Planning Board; Robert "Hoppy" Hobson for his seat on BPW; Town Moderator Mark Sylvia; Colleen Silvia for reelection as Commissioner of Trust Funds. Ms. Tomassetti, Mr. Hobson, and Ms. Fidalgo have returned papers.

The last day to obtain nomination papers is Friday, 2/8/24. The last day to return papers is Monday, 2/12.

You may register to vote Monday-Friday, from 8:30 a.m. to 4:30 p.m. The last day to register to vote for the town election is Friday, 3/22/24. The Town Clerk's Office will be open from 8:30 a.m. to 8 p.m. on that day.

Mail-in Voter Registration Forms are available at the Town Clerk's Office, the Millicent Library and State and Federal offices. Monday, 3/25, is the last day to submit vote-by-mail applications to the Town Clerk.

The election will be held on Monday, 4/1/24. Polls will be open from 10 a.m. to 8 p.m. All six precincts vote at the Fairhaven Recreation Center, 227 Huttleston Ave. (near Stop & Shop).

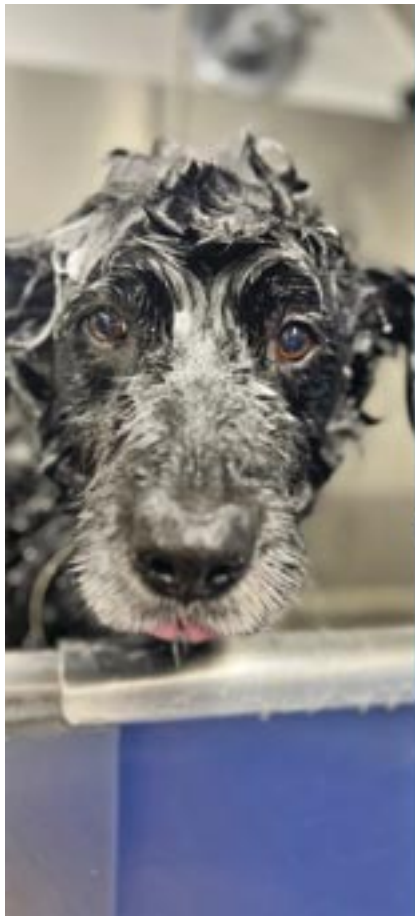
