

Vicki Oliveira case moves forward

A US District Court judge rejected motions to dismiss the Vicki Oliveira wrongful termination lawsuit, allowing the case to continue. The lawsuit names Town Administrator Angie Lopes Ellison personally and officially as TA. Ms. Ellison had asked for the court to dismiss on several grounds, with the court allowing in part and denying in part.

In the complaint, Ms. Oliveira alleges that she was terminated as the Assistant to the Town Administrator because she spoke out about changes to historic town hall that Ms. Lopes Ellison was proposing. The TA and Collector switched offices and the proposal was to remove the counter to follow the Collector.

Ms. Oliveira told her husband, Wayne Oliveira, who was chairperson of the Historical Commission, and he spoke out publicly against the changes, and he contacted the Mass. Historical Commission about the changes to the historic Town Hall, which is listed on the National Register of Historic Buildings.

In the complaint, Ms. Oliveira contends that after she spoke out about the changes, Ms. Ellison treated her in a "personally hostile manner."

Ms. Oliveira also contends that she was wrongly accused of violating a "duty of confidentiality." She claims that Ms. Ellison told her to send a notice out to department heads, and then "scolded" her for doing so.

In August of 2022, Ms. Ellison told Ms. Oliveira that she intended to terminate her from her position. Ms. Oliveira became "severely hurt and emotionally upset," and two days

later experienced chest pains while at work. Her husband arrived as paramedics treated her, and he and Ms. Ellison "engaged in a verbal altercation" over HIPPA issues.

The next day, Ms. Oliveira received a termination letter that contained "allegations that were false, trivial and out of context," according to the complaint.

Ms. Ellison also had a no-trespass order served on Mr. Oliveira.

The Court found that Ms. Oliveira spoke as a private citizen on a matter of public concern.

"All actions by Defendant Ellison, as stated above, were motivated by malice, anger, and retaliation for Plaintiff's communications and actions in regard to historic preservation of the interior features of Fairhaven Town Hall, and because of her marital association status with Wayne Oliveira, and their combined attempts to oppose the changes proposed by Defendant," reads the complaint.

As a result, Ms. Oliveira incurred "substantial damages, including substantial ongoing financial loss and physical and emotional distress."

The complaint alleges that Ms. Oliveira's "protected speech" and her association with her husband were

the motivating factor in her termination.

The complaint makes three claims. Count I: Violation of the Mass. Civil Rights Act (MCRA) versus Ms. Ellison personally and in her official capacity.

Count II: Tortious Interference with Advantageous Relations, versus Ms. Ellison personally. The claim is that Ms. Ellison knowingly and intentionally interfered with Ms. Oliveira's "advantageous relations with the Town of Fairhaven, namely her long-term employment with the Town of Fairhaven."

It also alleges Ms. Ellison did so with "improper motive and/or improper means"; and she acted with "ill will and actual malice."

As a result, Ms. Oliveira lost her long term employment with the town.

Count III: Violation of First Amendment Rights, versus Ms. Ellison personally and in her official capacity. The claim is that Ms. Ellison interfered with Ms. Oliveira's "protected speech and freedom of association with her husband under both federal and state law."

The claim alleges that Ms. Ellison's actions were in retaliation targeting Ms. Oliveira because of her speech as a private citizen and association with her husband. The termination is in violation of the Federal civil rights act.

There is no amount requested in relief in the US court, but Ms. Oliveira is asking for compensatory damages; equitable relief, including reinstatement or other relief necessary to protect her rights to free speech and freedom of association; attorney's fees and costs; pre-judgement interest. In the original filing in the trial court in December of

Select Board hears from department heads

The Fairhaven Select Board received updates from several department heads at its 2/12/24 meeting, including Cable Access, Marine Resources, and Human Resources.

Cable Access Director Derek Frates told the board his department recorded 307 meetings in 2023, the third year they have had more than 300. They have also covered 37 events on the government side.

The department has been a community resource and helpful to the various boards and departments, creating videos for a variety of reasons. For example, he said they helped the Health Department with guidelines and updates; helped created Public Service Announcements for the fire and police departments; helped the Animal Control Officer with the Adopt-A-Pet program; and a long list of other events they have helped departments. They have covered parades, events at the senior center, and events sponsored by town committees.

The department also just started a

new business spotlight feature focusing on new businesses in town.

On the public access side, the department has run shows for members of the public; covered events such as the Manjiro Festival, Father's Day Road Race, summer concert series; Halloween party; Benoit Square lighting, Old Time Holiday.

Mr. Frates said his department works with department heads to promote whatever they are working on, such as making videos to show at Town Meeting on warrant articles.

He said they will be sponsoring a candidate night again this year.

SB member Bob Espindola said the department had come "lightyears" from when Mr. Frates first started.

Mr. Espindola said he has sent many people to the department over the years.

"It's a great resource," he said, adding that the meeting coverage is now almost 100%, after the bylaw was passed.

Mr. Frates said only a handful were

missed due to technical reasons, but they try to record the Zoom session when that happens.

SB member Stasia Powers thanked him for being such a great resource for the community, especially new businesses.

Mr. Frates said he had a small staff, but they were hard working and worked great together as a team.

SB member Charlie Murphy, whose public access show "The Magazine" won an award because it was submitted by Mr. Frates, said when they were at the awards ceremony, he noted how respected Mr. Frates was by people all over the U.S.

"You're known," said Mr. Murphy. "You put Fairhaven on the map."

Human Resources Director Cameron Durant told the board that his team of three has been very busy. He said they have been reviewing the health care benefits and are "diligently" working on lowering costs for employees. He said self-funded is still the way to go.

Mr. Durant said they are also working with the police and school

The Rotch-Jones-Duff House & Garden Museum (RJD) is welcoming visitation from Fairhaven residents by offering free admission for the month of February 2024. Must have proof of residency with a piece of current mail, or I.D. For more information about hours of operation and current exhibitions, visit the Museum's website, rjdmuseum.org.

The historic house, now the site of The Rotch-Jones-Duff House & Garden Museum, was built in 1834 for whaling merchant William Rotch Jr. This Greek Revival mansion, located on a full city block of formal gardens, is a National Historic Landmark, one of only 2,500 in the nation. The period rooms of the house chronicle 150 years of the economic and social evolution of the City of New Bedford, as reflected in the residencies of the Rotch, Jones, and Duff families and their domestic staff.

The Museum is located at 396 County Street, New Bedford. It is open Wednesday through Saturday, 10 a.m. to 4 p.m. Advance booking for admission is encouraged, but not required. Admission is \$8 for adults; \$6 for AAA members, seniors and students; and \$3 for children (age 7–17). The Museum is free for RJD members, as well as for EBT, Connector-Care, WIC, and Wunderfund cardholders.

The RJD gardens are open to the public at no cost and available to visit from sunrise to sunset, seven days a week. Visitors are urged to go to rjdmuseum.org to book their Museum visit and to review the most current information on hours and programs.

New Bedford Whaling National Historical Park, 33 William St., New Bedford, has announced its programming commemorating Black History Month in February 2024. This year's theme chosen by the Association for the Study of African American Life and History (ASALH®) is African Americans and the Arts. - Hazelwood Senior Center (553 Brock Ave.): Feb. 29 from 11 a.m. to 3 p.m.

Additionally, absentee and mail-in ballots continue to be available. Any registered voter can request to receive one by visiting the Election Commission office at City Hall, 133 William St., during business hours, Monday-Friday from 8 a.m. to 4 p.m. Request forms have been mailed to registered voters in New Bedford.

In the Presidential Primary, New Bedford voters may cast their vote for president, state committee man, state committee woman, and ward committee.

The Choir is led by Tyrone Black, Associate Head of School at Tabor Academy. Its members sing mostly traditional gospel music with a few contemporary pieces. When asked why he founded the Choir, Black said, "Most places where I have worked, I started a gospel choir/ensemble as a way of bringing people together from all walks of life and singing about the Good News of Jesus Christ, and to spread the love of God through the ministry of song. I felt that Tabor had the right atmosphere/environment to start something new and inviting. It's a part of my identity, my spirit, my essence. It helps me and probably others find their place of belonging in a spiritually challenging world."

Most of the songs that will be sung are more traditional gospel songs from the late 20th and early 21st

century. They will range from old traditional pieces such as *God Is* by the Late Reverend James Cleveland, to more contemporary pieces called *Glory Glory* by New Direction. The Choir will also sing a piece with a Caribbean flare, entitled *He Reigns Forever*.

New Playwrights

The MAC Theater Playwrights Incubator is a program for first-time playwrights to see their work realized on the stage. Finding theaters to produce new or unpublished plays can be an obstacle for any new playwright. The MTPI is a structured program that aims to discover and support, through workshop and production, new stage plays by first time, unpublished regional playwrights. These plays are small cast shows with one to six characters.

Selected playwrights will work with two mentors who are experienced theater artists to fine-tune their plays over the course of several months and prepare the script for production. After regular writing evaluations, when the script is ready, the mentors will work with the MAC to find a director and assist her or him in casting the show with appropriate actors. One or more readings with a select focus group audience will include a feedback/response process, and the end result is a completed script, ready for debut performance for a live audience on stage at the Marion Art Center.

Any new writer who has not yet been published or had a play produced is invited to submit her or his script or outline for consideration. There is no cost to participate in this program. Playwrights must be available to meet on site with mentors, for readings and all aspects of the production process including auditions, rehearsals, tech work and performances. Apply online at marionartcenter.org/mtpi. Applications are due by March 31, 2024. The selected playwright for the 2024-2025 program will be announced in early May. Although the exact origins of the Sailor's Valentines are not clear, documentation shows that they were given as a token of affection by sailors to their loved ones. Sailor's Valentines were most likely not made by the sailors themselves but were handcrafted by women in Barbados, a popular destination amongst whaling ships between 1830-1890. Sailors would then purchase these trinkets at souvenir shops while in port.

Join everyone at the Museum to experience this long lost art for yourself and walk away with an heirloom to be cherished for years!

Recipe of the Week

Egg Muffins

A great way to get your morning egg fix on the go! Carry them in a resealable bag and get bites of tender egg, with plenty of fresh, bright veggies baked right in!

- Extra-virgin olive oil, to taste, for greasing the pan
- 2 medium red bell peppers, diced
- 1/2 cup scallions, chopped
- 9 large eggs
- 1 clove garlic, grated
- Sea salt, to taste
- Ground black pepper, to taste
- 3 tablespoons all-purpose flour
- 3/4 teaspoon baking powder
- 1/3 cup feta cheese, crumbled

Preheat oven to 350°.

Grease a nonstick muffin tin with the olive oil.

Evenly divide the red bell peppers and the scallions between the muffin cups.

In a large bowl, add the eggs and whisk them until beaten well.

Add the garlic, the salt, and the black pepper to the eggs and whisk to combine.

Sprinkle the flour and the baking powder on top of the eggs and whisk well to combine.

Divide the egg mixture evenly into the muffin cups.

Sprinkle the feta evenly on top of the egg mixtures in the cups.

Bake until the eggs are set, about 22-24 minutes.

Allow the Egg Muffins to cool slightly before serving.

Kool Kids do cool stuff on school vacation week

The Fairhaven Recreation Center's Kool Kids program had the kids running around letting off steam inside the gym, playing "Jailbreak," a dodgeball game.

Groups of kids are behind the partitions in "jail" while their

teammates throw the ball to them and guards try to block them. If a prisoner catches a ball, the whole cell block goes free. The game ends when everyone is in jail. You end up in jail when you get hit with a dodgeball.

It's a bit of controlled chaos, with balls flying around, kids running around, and lots of hooting and

hollering.

"They love it, and they're tired afterwards," said Michaela, one of the Rec Center workers keeping an eye on things (and playing, too).

No one is ever "out" in Jailbreak, which means everyone is always in the game.

departments to change the process and streamline payroll.

They are also making some minor changes to the personnel policy; and they created a new employee handbook.

Mr. Durant said one of the "most daunting" tasks he has is to reorganize the personnel file, including individual files and contracts.

Mr. Espindola noted that the town has only had a Human Resources department for a few years. He asked Mr. Durant to explain what that means for risk management.

Mr. Durant said from a labor standpoint, his department needs to make sure the town has the proper documents for compliance in a number of areas including sexual harassment; and making sure everyone is treated with equity in regards to pay, reviews, discipline.

He said his department also handles Workers Compensation claims, and looks into problems areas for safety concerns. His office has also taken over property liability insurances.

Mr. Murphy said HR is the hardest job in any town.

SB member Keith Silvia said some people have questioned why the town needs an HR department. He said Mr. Durant just explained it.

HR helps to avoid potential liability, which results in savings, said Mr. Durant.

SB Chairperson Leon Correy asked what changes they were making to the personnel policy.

Mr. Durant said they did a holistic view and tried to balance the "employee experience."

He said when it is about employee retention, compensation is a factor but it is not everything. Feeling valued and receiving certain benefits can make up for lower pay.

He said they are trying to honor experience, a work-life balance.

"It's the small things," said Mr. Durant, like sprucing up the break room.

It helps build a culture, and now people use that room.

Ms. Ellison noted that Mr. Durant had just received a certification as a Senior Certified Professional from the Society for Human Resource Management.

Harbormaster Timothy Cox also updated the board on his depart-

ment, noting that they have three major projects going on.

He said there is a light at the end of the tunnel for the dredging on West Island. Back in 2002, the project got stalled because they could not find a suitable place to dump the sand because they could not match the grain size. Now, due to the accelerated erosion across the state, officials have relaxed some of those rules. He said the Seaport Council has funding available for the project.

The issue, however, is still where to put the sand. Renourishing a beach close by would be the best option; dumping it out at sea would be the most expensive; using it on the CAD cells in New Bedford Harbor is the cheapest, but does not help the town

with beach erosion. Mr. Cox said they are looking at all options.

The second project is the Union Wharf reconstruction. He said it is moving along very well. Contractors will be working on different parts of the wharf.

The third project is dredging in the harbor. There are about 20 sites on the Fairhaven side. That project should be finished at the end of this year. There are commercial and private sites, he said. They want to dredge at the marinas now, before all the summer boats come in.

Mr. Cox told the board that the new motors on his boat are in and his department is getting ready for boating season to begin. The mild winter, though, has meant that some people have been quahogging all winter long. He said he had about 10 people digging on a recent warm day.

Mr. Murphy commended Mr. Cox on his collaboration with New Bedford and making sure Fairhaven waters are never forgotten.

Mr. Cox said they help each other on both sides of the harbor.

He said he appreciates the support he gets from staff at town hall, his staff and the Town Administrator's office. His job changes every day, he said and it helps to have office support.

"I love my job," said Mr. Cox. "I'm outside every day. I'm by the water every day."

He said he never knows what will happen next.

"It's just crazy," he said. "But just the support I get from our team is unbelievable."

Ms. Powers said there had been a real issue with the culture in town hall. Now she hears the department heads talking about "extensive collaboration" they have with other departments.

"It's a big difference. And I want to point that out," she said. "The happier the staff is, the better quality product we produce for our community."

In another matter, the board approved an electrical "passageway" through Hoppy's Landing for Eversource to run electricity to Blue Stream Shellfish, which operates on the abutting property.

Dale Leavitt told the board that the company has been waiting for Eversource to provide electrical service for more than three years. The town has allowed Blue Stream to use the service at Hoppy's Landing, with the company paying for the electric at that property, too.

Eversource finally contacted them to move forward with electrical service, however, they found that the only way to get it to them would be to tie into a main on the opposite side of Goulart Memorial Drive, which would require digging a trench across the road. Or, they could access the feed at Hoppy's. But to do that, Eversource needed the okay from the board to cross the property with the power line, which will be underground.

Mr. Leavitt said the project would also upgrade the service at Hoppy's to 200 amps.

The board voted unanimously allow the passageway.

The board also convened in executive session for two items: to review executive session minutes from 12/18/23; to conduct strategy/negotiations for non-union personnel contracts (Angie Lopes Ellison).

2022 (the case was moved), Ms. Oliveira asks for \$430,000: \$30,000 in documented lost wages to that date; \$300,000 in reasonably anticipated lost wages; and \$100,000 for "hospital visit with medical treatment, stress with associated psychotherapy assistance."

On January 11, US District Judge Denise Casper, issued a 17-page memorandum and order that allowed two motions to dismiss, but denied two motions to dismiss, allowing the case to proceed.

Ms. Ellison's filing last April asks the court to dismiss the case, citing six reasons, including that the town used "legitimate means to terminate" Ms. Oliveira; plaintiff fails to allege "policy or custom" in her claimed federal violation; her First Amendment rights were not violated; she failed to allege threats, intimidation, or coercion as required; the defendant is entitled to qualified immunity; plaintiff fails to allege "actual malice" to support her intentional interference claim.

The court allowed the motion in part and denied the motion in part.

It dismisses Count I, which alleges violation of her free speech rights under the Mass. law (not federal). The court allowed that because the MCRA requires that the plaintiff show her First Amendment rights were violated because of a municipality's policy or custom.

In her opposition to the motion to dismiss, "Oliveira does not offer any argument as to municipal liability," wrote the court.

The court allowed Count III, the alleged violation of Ms. Oliveira's First Amendment rights, distinguishing between a public employee's citizen speech, "which triggers protection, and employee speech, which may be disciplined by the employer."

The Court found that Ms. Oliveira spoke as a private citizen on a matter of public concern.

The Court also found that Ms. Oliveira "pled sufficient factual allegations" for the court to infer that she was terminated based on her speech.

The court also denied the motion to dismiss the "tortious interference

claim," the allegation being that Ms. Ellison fabricated a reason to fire Ms. Oliveira, or created a "pretext."

The court also denied the qualified immunity argument.

"For the foregoing reasons, the Court **ALLOWS** [Ellison's] motion to dismiss, D. 7, as to the MCRA claim (Count I) and the § 1983 claim (Count III) brought against [Ellison] in her official capacity, but otherwise **DENIES** the motion to dismiss so that Counts I and III survive as to [Ellison] in her personal capacity and Count II, the tortious interference claim, also survives. The Court also denies the request for qualified immunity of [Ellison] without prejudice."

According to court documents available online, the next step is mediation, but no date had been set.

In a phone interview and email correspondence with Ms. Oliveira's attorney, Philip N. Beauregard, he said, "The opinion speaks for itself," adding that the next step is to prove it.

He said the case is, "All about pretext."

Ms. Ellison would not comment on ongoing litigation.





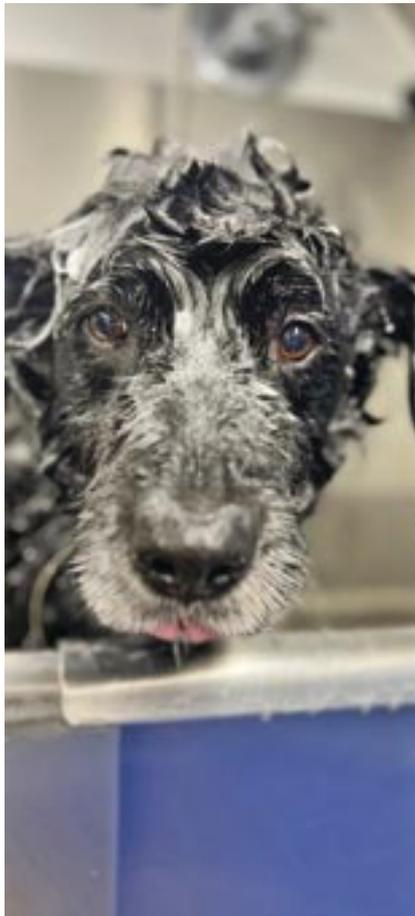
