

Fire closes East Fairhaven School due to smoke damage

East Fairhaven School will be closed until at least Thursday, 9/26/24, due to a fire. A fire alarm went off at 7:25 p.m. on Sunday, 9/22, leading firefighters to the second floor. Smoke and heat detectors in Rooms 232 and 240 were activated.

Firefighters located the fire on the exterior wall of room 232 and were able to extinguish it with their water extinguisher.

"The cause is still under investigation but is believed to have been caused by a dual blade window fan plugged into an outlet on that exterior wall," wrote the Fire Department in a press release.

According to a press release by Superintendent Tara Kohler, the fire department extinguished the fire quickly enough to keep the sprinkler system from engaging.

The damage was contained to one section of the wall near the outlet.

"After the fire was put out, quite a bit of smoke and soot throughout the second floor needed to be cleared," according to Ms. Kohler. To properly clean all soot and smoke damage, East Fairhaven School will also be canceled through Wednesday. The district plans to reopen the school to all students and staff on Thursday, 9/26

"After a preliminary investigation, the Fairhaven Fire Department informed district officials that the cause of the fire was a double fan that likely had an internal wire malfunction,³ wrote Ms. Kohler. "We thank the Fairhaven Fire Department for their swift response and support."

Fairhaven SB gets Wind Turbine update, request

The Fairhaven Select Board held a marathon meeting on Monday, 9/23/24, even though they passed over two items that could have taken up a lot of time. The meeting ran until almost 11 p.m.

The board heard from Fairhaven Wind developer, Sumul Shah, who constructed the two wind turbines (WTs) on Arsene Street near the Wastewater Treatment Plant, and owns the project. The town has a lease agreement with Fairhaven Wind for the use of the land the WTs are on; and the town has a contract to buy the electricity produced, although it all goes through a rather complicated process involving Eversource and transmission and distribution costs.

The project has resulted in \$4,000,000 in benefits to the town.

Mr. Shah gave an outline of the projects successes and failures over the past 12 years. He said the town has been making money from the project, but the last few years production has been down. He said the town has not seen a downturn in revenue because electricity costs are so high, not because of productivity.

In a nutshell, the WTs need an overhaul and it will cost millions. The company is looking for the town to renew the lease according to the current contract, but also to change the way the town pays the company for electricity. Mr. Shah said he needs a more stable revenue projection to get a loan to rehab the turbines.

The turbine manufacturer is no longer in the US due to a lawsuit against the Chinese company for stealing technology. Mr. Shah said his company has partnered with a variety of maintenance companies to keep the WTs running, but they are reaching the point when that will not be feasible.

Mr. Shah has found a different company that has components that will fit the WTs on Arsene Street, but the project will cost millions. The refit will increase production from 1.5 megawatts to 1.85 megawatts if Eversource will allow it. He is also hoping Eversource will allow them to create a battery backup system to help with regulating transmission.

He said the biggest problem they have is that Eversource kicks them off the system if there is a problem and it can take days to get producing again. The refit and the battery backup will help with some of that interruptions.

He is asking the town to incorporate the transmission and distribution rates into the fixed rate it pays to his company. That way there is no variability and he can get a loan from the bank.


Mr. Shah and board members discussed details of how that change would look.

The board did not vote on the change, but asked Mr. Shah to get more information to them, and to work with Town Administrator Angie Lopes Ellison, Anne Carreiro, Assistant Town Administrator of Finance/Town Accountant. The board will discuss it at a future meeting.

In another matter, Fairhaven Police Chief Daniel Dorgan formally introduced Cooper Howell, Fairhaven's newest police officer. He graduated from the academy in Fitchburg on 9/13/24, and was sworn in on Monday, 9/16. (See 9/19/26 issue.)

Chief Dorgan said he was skeptical about the Fitchburg program because students go directly from the college's

Hetty's Here!

A little more than a century ago, Hetty Green, born in Bedford Village (New Bedford), was the wealthiest woman in America. Though she inherited a small amount of money from her whaling wealthy family, she earned financial fame as the first successful woman trading in Wall Street, but remembered by many as the "Witch of Wall Street." Brave and brilliant, Hetty left between \$100 million and \$200 million to her son, Colonel Ned and her daughter, Sylvia.

The New Bedford Whaling National Historical Park at 33 William Street will offer an introduction to Hetty's life and legacy at 1 p.m. on the following Sundays. Free admission.

• 10/6 Hetty's Herstory: Her life in Bedford Village, her family, marriage and learning the men's world of finance.

• 11/3 Hetty and \$\$\$: Shrewd and determined, she had her own savings account at eight years old and grew into real estate, loaning, stocks and bonds. Yet she often offered low interest loans, especially to churches.

• 12/1 When she died in 1916, her enormous wealth was inherited by her son and daughter, but the money disappeared in one generation.

The Town of Acushnet will hold a Special Town Meeting this Monday, 9/30/24 at the Ford Middle School, 708 Middle Road, at 7 p.m.

Town Meeting will be asked to vote on 17 articles, with spending articles ranging from a few thousand to \$4.2 million. Bills of prior years totals \$14,178. Article 2 requests \$9,500 for the Assessors Department to correct budget expenses. Article 3 asks for \$47,818 for MS-4/stormwater permit compliance from the Stormwater Management Stabilization Fund.

Other spending articles include: funding union contracts, \$19,775; \$550,000 from Solar Tax Revenue to fund the school roof; \$5,500 from EMS reserve fund (ambulance receipts) to fund a study for the fire department in the areas of Operations, Staffing and Facilities to improve operations and create a Capital Improvement and Staffing Plan; \$49,999 from the EMS fund for renovations to Fire Station #3; \$660,000 for a new ambulance; transfer of \$186,026 from the Special Education Fund to pay special education and recovery high school programs, out-of-district tuition or transportation for special education students

Three articles ask to authorize the Select Board to enter into contracts for \$4.2 million for Energy Management Services and Energy Savings at the Acushnet Elementary School and the Ford Middle School. The articles were requested by the School Committee and have no recommendation from the Select Board or the Finance Committee, which will report at TM. They require a 2/3 vote.

Town meeting will also be asked to

remove Section 3-1-2 of the Town Charter which prohibits elected and appointed officials from taking a paid job with the town for at least two years after the expiration date of their term.

In the explanation, the Select Board writes: "This restriction places a draconian constraint on filling vacant positions with competent candidates. It also is somewhat redundant in that the Massachusetts Ethics Law sufficiently restricts public officials from benefiting or participating in matters that they dealt with as elected officials."

Other bylaws changes include amending the Soil Conservation Bylaw.

Fairhaven man thanks first responders for saving his life

Mark Paquette thought he was having heartburn, although he had never had it before so he wasn't quite sure what it felt like anyway.

"Come to find out, I was having little mini-heart attacks," Mr. Paquette said in a phone interview.

Then he had a couple of other episodes: one when he was sweating a lot, and the Tums just didn't seem to be helping as much. He called his son to take him to the hospital, but his son called 911. They both arrived at the same time on Friday, 9/13/24

"They literally saved my life in the driveway," said Mr. Paquette. Paramedics assessed him quickly, according to a post on the Local 1555 Facebook page. They confirmed he was having a heart attack and then his heart stopped requiring immediate defribillation.

He was taken to Charlton Memorial Hospital in Fall River where they operated on him, putting in stents.

Mr. Paquette, 56, said his heart stopped again at the hospital.

"When they put the stents in, the

very next day, I felt like a million bucks," said Mr. Paquette, a carpenter, who is anxious to get back to work, but has to wait until he is cleared by his doctor. He was out of

the hospital by Monday.

"It could've gone south," said Mr. Paquette, adding everything was "perfect" because it happened in the ambulance where paramedics could work on him immediately.

Mr. Paquette paid a visit to Group 4 at the Fairhaven Fire Department and treated them to lunch to say thank you. Then called he the Neighb News so the community will know about parademics.

"I just thought these guys should be recognized for what they do," said Mr. Paquette. "I didn't realize how PAQUETTE: cont'd on page 17

Slim pickings at Fairhaven town auction this year

Fairhaven's annual town auction of surplus property had slim pickin's this year on a rainy Saturday morning, 9/21/24. There was very little office furniture, and no bicycles, which are usually a big draw. The one bike from the Marine Resources Department disappeared after being declared surplus, but before it made it to the public works barn, according to Harbormaster Tim Cox.

Some chairs from the Oxford School and a few letter organizers were about it for office stuff.

The biggest ticket item was a 1991 Fairhaven Fire Department bucket truck that sold for \$750 to Patrick Corkery, who let his son, also Patrick, do the bidding. The younger Corkery bought several items and even got a round of applause for outbidding someone for a kayak, with a winning

bid of \$75.00

Marine Resources sold, one for \$20 and one for \$1.

A 1989 Fire Department box truck sold for \$200, also to the younger Corkery.

Several pieces of old equipment from the sewer department also got snapped up: a trash pump for \$50, a sand blaster for \$50, a Roto rooter for \$20. A Huskee riding lawn mower that did not run, went for \$1 to Susan Dwyer.

The auction is held in September every year to dispose of items that have been declared surplus by the

criminal justice program into the academy. After visiting and learning more, however, he was convinced.

"I think it's a great program," said Chief Dorgan, adding that in the future he hopes to get more candidates from there.

The board also voted to approve the Ms. Ellison's appointment of Alyssa Botelho to the Community Development Coordinator position that is the new iteration of the Director of Tourism job, which has been vacant since Chris Richard retired in May.

Ms. Botelho currently works in the town's Cable TV department. She is also known around town as an independent film maker, and she works as Marketing Manager for BOLD Real Estate.

SB Andrew Romano recused himself from the discussion and left the room because he is a Real Estate agent with BOLD.

The board also declared as surplus a weathervane that was on the Oxford School. The request from the Historical Commission was to give it to the North Fairhaven Improvement Association to restore it and display it, however that organization voted not to accept it.

John Medeiros and Jeff Lucas, both members of the NFIA, asked the board to give it to them, saying they believe it does have historical value despite the determination of the Historical Commission.

There was guite a bit of discussion about how to go about declaring a piece of town property as surplus and giving it to specific individuals, instead of offering it to the public for purchase.

"I am very passionate about this weathervane," said Mr. Medeiros, adding he was not sure where it should go, but it should not be scrapped.

He said the vocational students might be able to restore it, and he can reach out the Lions Club, where he is also a member.

"I find it hard to believe it has no historic value," said Mr. Lucas, and discussed the difference between monetary value of an object and the historic value it may have to a place.

"If you're going to toss it out, toss it out into my truck right now," said Mr. Lucas.

In the end, the board voted to declare it surplus property and suggested Mr.

Medeiros and Mr. Lucas talk to Ms. Ellison about how they can acquire it.

The weathervane has been stored at the Millicent Library for about 10 years and needs to be moved.

The board also voted to approve winter storage for boats at Hoppy's Landing for \$25 per foot. Harbormaster Tim Cox said the property is dormant in the winter and it can hold a lot of boats, which will provide revenue for the town.

After the meeting the Neighb News asked if money generated at Hoppy's Landing can be moved to the general fund or if it has to go into the Hoppy's Landing Revolving account to be used only at Hoppy's Landing. The board did not have a clear answer by press time.

The board also met in executive session to discuss the use of town counsel and who on the board would have access to that, a continuation of a discussion that began in open session at a previous meeting. After the executive session, Ms. Powers said the board had made changes to the proposed protocols and would present it to the public at the next meeting.

Acushnet plants tree in memory of Norman Fredette

The Town of Acushnet recognized Norman Fredette, who died unexpectedly in May after a short illness, at the age of 64, with a tree planting on 9/24/24. Mr. Fredette was the town's Tree Warden at the time of his death, and had served on the Board of Public Works. He was an outspoken and well known member of the community.

Acushnet Town Administrator Jamie Kelley spoke to a crowd of about 25 friends, family, and town officials after the tree was planted in the Parting Ways Green between Town Hall and the Parting Ways building.

"There are people who contribute their time and skills to making their community a better place to live. Norm was one of those people," said Mr. Kelley. "He was also our tree warden, a job he did well for many years."

Mr. Kelley said many people in Acushnet appreciated Norm, as is shown by the dedication of the tree.



He said he always felt better after talking to Norm.

"I know I will miss him and his raunchy jokes and his parting words: 'God bless,'" said Mr. Kelley. "God bless Norm."

Mr. Fredette's wife, Maria, was on hand, and said it was a "great honor," and she was "very overwhelmed" with the love and support of the town.

"I knew he was well liked," she said. "But now I really know how loved he was."

Mr. Fredette's daughter, Sara, said she felt "very nostalgic and honored by the town planting a tree for him."

"He's been part of many things in Acushnet," said Sara.

"He was such a beloved person, we felt we had do to something," said Mr. Kelley after the ceremony, adding that Sydney Viveiros in his office spearheaded the effort.

Ms. Viveiros said she thought a tree for the tree warden was a good idea. They ordered the tree in the spring, but had to wait for the proper time to plant it.

After the ceremony, the public was invited into town hall for coffee and pastries. Many people lingered outside in the green in the comfortable fall weather.

Acushnet staff raised \$500 for the project, plus a house plant they gave to Mr. Fredette's family in May. Roseland Nursery donated the cost difference for soil and fertilizer; Bob Medeiros of A. Medeiros Contracting donated his time and machinery to dig the hole; maintenance staff, Matt and Brady, planted the tree and installed the memorial plaque.

The tree is a Lavendar Twist Redbud. It blooms purple buds in the spring, has large leaves for the rest of the summer and fall.





hard their job is."

He said he is old school, does not go to the doctor as often as he should, and was stubborn about it that night, too. But he was especially grateful that his son had the sense to call 911.

"I would've died in front of my son," said Mr. Paquette. "That's how quick it happened."

He said doctors tell him he is headed for a full recover, but it will be a long time, several months. Meanwhile, he can't work. He cautions anyone who has heartburn who never had it before.

"Chances are there's more going on than what they think," he said.




