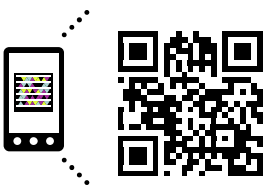

# Fairhaven Planning Board holds bizarre five-minute meeting

The Fairhaven Planning Board held a meeting on Tuesday, 9/23/25 that lasted less than five minutes after four members walked out.

The agenda, after two revisions, had a "Public Informational Q&A regarding the Timothy Street and Hiller Avenue Subdivision Project."

Deleted was the section that said Dave Davignon, project engineer, would share information about the project. Q&A would be directed to the Land Use and Planning Director, Bruce Webb.

Many abutters were present.

As soon as the meeting started, Kevin Grant read a statement that read in part: "Madam Chair, due to the absence of legal counsel, which has been repeatedly requested for tonight's proceedings, I do not feel it is wise to continue, nor is it fair to the residents."

He said he would not take part in the proceedings and advised other members to do the same. He walked out, followed by PB members, Jessica Fidalgo, Miles Grant, and Sean Powers.

"Well, this is all new to me everybody, thank you," said PB chairperson Dianne Tomassetti.

She said because there was no longer a quorum they would have to table the issue to the next meeting on October 14.

Someone in the room asked if there had been requests for town counsel.

"I can't exactly explain to you but

at the time there was seemingly no need for counsel so they were not invited," said Ms. Tomassetti.

Bob Espindola, an abutter to the project, asked that the documents distributed be read into the record, or he should take them back.

Ms. Tomassetti suggested that he take his documents back.

PB member Patrick Carr asked if any board member in the past two weeks asked for town counsel to be present.

"Not one," said Ms. Tomassetti.

"Not true," called someone from the room, who was later identified to the *Neighb News* as resident, Amy Goyer.

"We're not asking anybody to talk right now," said Mr. Carr.

He repeated his questions, were there any submissions or requests for town counsel by any board member.

"I'm not aware of any," said Ms. Tomassetti. "Thank you. This meeting has now ended."

A bit later on Facebook, PB member, Kevin Grant, posted a series of screen shots\* which show a back and forth between him and Ms. Tomassetti, and between him and Interim Town Administrator, George Samia, asking for Town Counsel, from 9/23/25, the same day as the meeting.

In those exchanges, Mr. Grant asks for TC to be present. Ms. Tomassetti responds that TC will be available by text if necessary, but will not be at the meeting. She says that the meeting is informational only, so TC is not required.

# Fairhaven Select Board agrees to ride-along for Rochester Police

At its meeting on 9/22/25, the Fairhaven Select Board agreed to allow a Rochester police officer to ride along with Fairhaven police; accepted two proposals from Fairhaven Wind that they would discuss in executive session.

Fairhaven police chief, Daniel Dorgan, told the board that the Rochester Police Department tries to have the same amount of field training as Fairhaven, but Rochester does not have the call volume that Fairhaven has.

He said it is not unusual for them to go a whole night shift without a single call, but Fairhaven is very busy. He said Rochester Police Chief Michael Assad is "very forward thinking," in getting his department where it needs to be.

He proposed that the officer who is now in his field training phase ride along with Fairhaven officers for two weeks.

Chief Dorgan said the two towns already have a mutual aid agreement. Lt. Swain would work on the evalua-

tion and report back to Rochester.

Interim Town Administrator, George Samia, said the town's labor counsel also represents Rochester, so that is why it was before the board. She would feel more comfortable if the board voted on it, he said.

SB member, Andrew Saunders, asked how the arrangement would benefit the town.

Chief Dorgan said because Fairhaven has a mutual aid agreement with Rochester, it is in the best interests of both towns for officers to be similarly trained. He also said there was a money component to it because of the mutual aid agreement.

Mr. Saunders asked that the town make sure the insurance is sufficient to cover the situation. He also suggested they add a dollar amount, even if just \$1.

The board voted to approve the agreement with the amendments.

The board also received two proposals from Fairhaven Wind that were not made public. An executive session item was scheduled for the end of the meeting to discuss the proposals.

Project owner, Sumul Shah, summarized them saying that one is to repower the turbines, which would require a change in the contract with the town. He said if they decided to go that route, he would have to order parts by July of next year. There is much to be done before they are ready to order parts, so he urged the board to act quickly.

The second proposal is to accelerate the timeline for the town to take over the project completely. That would give the town the control to shut down the turbines whenever there were complaints from abutters.

Mr. Shah and Mr. Saunders had a bit of a back-and-forth about a request made by Mr. Saunders. Mr. Shah seemed to think he had gotten the information.

Mr. Saunders said he had wanted Mr. Shah to find out from the Building Commissioner if he would issue a permit for the repowering of the WTs considering the bylaw had changed.

In the end the board voted to have Mr. Shah meet with both Mr. Saunders and the Building Commissioner to clear up the misunderstanding.

### Comment Utterly Abhorrent

The tragic murder of Charlie Kirk in Utah on a college campus has left many of us stunned and in deep sorrow. This cowardly act has taken a person's life, leaving a wife, now widow, to mourn and two children to grow up without ever knowing their dad. Parents received devastating news that that no parents should ever hear, that their child was dead. This brutal killing casts a heavy shadow across our nation and our own community of Fairhaven.

Like so many others, I was saddened by this senseless crime against a man who sought to publicly engage with our youth, sharing his beliefs in patriotism, government and religion. # Feds take three workers in Fairhaven

Federal agents, presumably ICE (Immigration and Customs Enforcement) arrested three men who were on their way to work to paint a house in Fairhaven on Friday, 9/19/25. The agents stopped the van that was carrying the men on Middle Street, near the Pease Park boat ramp at about 7:30 a.m.

Ann Richard said she had worked on some weeding near the bike path before work and was heading to her job when she noticed the agents in the street. She turned around and confronted them.

"I said, I can't just drive by this," she told the *Neighb News* in a phone interview, adding she could not just let them do what they wanted without challenging them.

She said one agent was "huge" and tried to intimidate her. She said she did not care, telling him he could not do anything to her.

She first told them to take off their masks and show her their badges, she said, asking them what they were doing there.

"They screamed at me, 'you're not supposed to be in the street.' I said 'you're in the street,'" she said, and told them they had no authority over

her. "I kept questioning them, 'why are you here,' and I said 'I'm not

# Harborfest goes out with a “hear ye, hear ye”

As the start time of Saturday's Medieval Faire neared, Alyssa Botelho and her crew of Discover Fairhaven volunteers were rushing around Grimshaw Park at Fort Phoenix, putting the finishing touches on the final event of the Huttleston Harborfest series.

The preparations paid off, as a steady stream of fair(e)goers came and went all day and into the night, most wearing costumes or at least a smile.

“We were very happy, it was a lot of fun,” said Botelho, the town's Tourism Director. “It was definitely a great day, and we're confirmed to do it again next year.”

Scores of vendors with a medieval theme, “or at least medieval-adjacent,” in Botelho's words, were on hand, along with live music and a nighttime screening of “A Knight's Tale” with a special guest emcee, Oscar-winning writer-director Brian Helgeland.

When you're running an event with multiple vendors from different towns and with different approaches, there's a tell-tale sign if things are going well or not: what's the vibe like with 15 minutes left in the official run time?

“A lot of times, at that time the vendors are packing up to get going,” Botelho said. “But people were still interacting, buying and selling way past close (4 p.m.), and that was great to see.”

On a beautiful last Saturday of summer, the parking lots and roadsides were packed; not an uncommon experience at Fort Phoenix. But on this day the focus was on the small park above the tennis courts, where scores of tents were occupied with an assortment of off-beat vendors and food trucks were ready to serve.

Over the outdoor speakers, medieval versions of an eclectic group of modern songs lilted above the grounds: Nirvana's “Smells Like Teen Spirit” and Michael Jackson's “Beat It” translating surprisingly well to lute and harpsichord.

Flags with town territories flapped high in the wind, representing East Fairhavenshire, The Centre Towers, Isles of Sconticut and Olde Oxford Village. The port-a-potties even were in the spirit, as signs pointed the way to “Ye Royal Restroom.”

Mike Akin of Acushnet was there with a display of his homemade “Clever Meadows” candles.

“It's something I've been doing the last few months, kind of a hobby, I'm just here to see how it goes,” he said.

A collection of folks in period garb represented “The Society for Creative Anachronism,” a national organization dedicated to the crafts and skills of the Middle Ages and Renaissance.

At one point an announcement came over the PA: “Hear ye, Hear ye,” it began ominously, then: “We are looking for the owner of a Honda Odyssey, license plate number ...”

People could collect a gold coin from the Discover Fairhaven stand and leave it in the treasure chest on their favorite vendor stall. The winner was C o l o r l o o m Designs of New Bedford, which had a table full of intricate, angular 3D printed products that were on brand for the event - swords, steins, dragons, etc.

“Some of the designs, we do ourselves, some we license, and



we work with multiple different artists,” said Cristina Cairo, who started the business with her husband two years ago. They were there with their two daughters, in period garb. “We don't normally do dragons, but we knew they'd be popular with this event. It's fun!”

The Harper and the Minstrel, aka Jay and Abby Michaels, played multiple sets of Celtic music, and costume contest winners were crowned in several different divisions.

The nighttime portion was a live screening of the classic movie “A Knight's Tale,” which was introduced by its creator, Brian Helgeland.

“I had always wanted to connect with Brian, dating back even to high school,” said Botelho, a filmmaker in her own right. “But there was never a direct reason to. I thought this was a great opportunity to try and get him, so I basically emailed his agent every week until he said yes!”

Helgeland, whose latest movie “Finestkind” was set in the New Bedford fishing industry, spoke to the crowd about the importance of pursuing dreams, which is at the heart of the movie and in his personal arc from local kid with ideas to Hollywood powerhouse.

“The whole theme of the movie is that a person can change their path,” Botelho said. “He was sharing stories all night, it was great.”

This was the last in a series of five Huttleston Harborfest events, and wrapped up the first year of Botelho's stint in the town's tourism office.

“It felt like the big grand finale, definitely,” she said. “I learned so much about event layout, and the way my team works. Learning who can do what and what the process is, I think we really came a long way.”

In the wake of three serious crashes on Route 6 across Pope's Island this year, at least two of them fatal, dozens of concerned citizens from across Fairhaven and New Bedford gathered September 16 for a walk audit of the corridor.

Organized by SouthCoast Places for People with staff support from the Southeastern Regional Planning and Economic Development District (SRPEDD), participants included members of the Fairhaven Select, Planning and School Boards, Fairhaven Fire, Fairhaven Police, New Bedford Police, Fairhaven BPW, and Fairhaven Livable Streets, as well as concerned neighbors.

Participants met at the Noah's Place playground and walked from the Pope's Island Marina east to Fairhaven High School, documenting conditions for people walking, biking, and driving. Among the key findings:

- Despite posted speed limits of 30-40 miles per hour, participants measured average vehicle speeds of 52 mph. A law enforcement official reported that vehicles are regularly clocked above 50 mph along Pope's Island and that police often only

pull over drivers traveling at least double the speed limit.

- No congestion was observed on Route 6 during the weekday peak hour (5-6pm). The only slowdown occurred when the swing bridge closed to through traffic at the quarter hour. Westbound queuing for the bridge is further exacerbated by left-turning vehicles into the commercial plaza.
- Even with more people crossing between the marina and playground to the south and businesses to the north, there is no crosswalk at all on the nearly mile-long stretch of Route 6 across the harbor connecting the marina/playground to the retail businesses on the north side, despite this being a common crossing point and the site of a serious pedestrian injury last July. Audit participants observed several people attempting to cross with considerable difficulty.
- Despite most businesses being on the north side, limited access to New Bedford from the north side and no bike infrastructure means most people walking and biking share the south sidewalk, too narrow in multiple locations to accommodate two-way traffic.

- The crosswalk on the west side of the Main Street intersection is 71 feet long and signal timing for pedestrians crossing from Fairhaven High was too short for even a group of able-bodied adults to cross safely on time.

Recommendations from the audit include:

- Immediate safety fixes (lighting, trimming hedges, clearing obstructions, signage corrections).
- A near-term pilot project to get vehicle speeds to better match limits on the bridge and the commercial stretch.
- Longer-term redesign recommendations to better reflect the values of safety, freedom to move, and community connection along this important gateway between Fairhaven and New Bedford.

SouthCoast Places for People and SRPEDD will continue working with MassDOT, elected officials, local committees, businesses, and nonprofits to keep people informed and gather feedback.

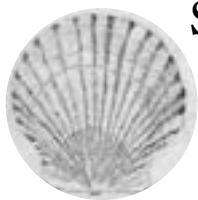

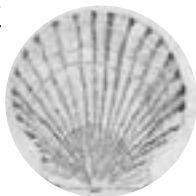

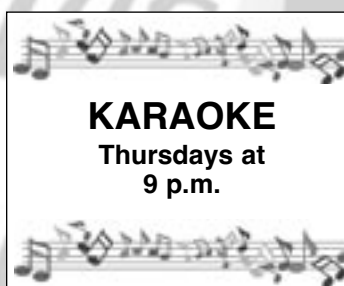
