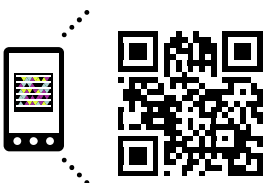

# Old Colony building vote is next week for Acushnet

The Acushnet Selectboard and Finance Committee held another joint meeting with representatives of Old Colony Regional Vocational Technical High School (OC) on 11/10/25 to get more information on the proposed new school building and its financial impact on Acushnet taxpayers. The meeting was the third and was requested by the FinCom.

FinCom chair, Mike Boucher, said inaccurate information was being circulated on social media, so he wanted to be able to clarify some issues.

The five member communities of the district will vote on 11/18/25 on whether or not they will fund the \$288,743,683 building project at the school. The Mass. School Building Association is expected to reimburse the district \$129,675,235, leaving \$159,068,448 for the district members to pay.

Acushnet's share will be \$55.4 million, but could go down to \$40 million with added incentives and other savings such as MassSave and

other programs.

Other communities are: Carver, \$26.2m; Lakeville, \$39.6m; Mattapoisett, \$8.8m; Rochester, \$28.8m.

The costs to repair the existing building are not much better: Acushnet, \$46.8m; Carver, 22.1m; Lakeville, \$33.5m; Mattapoisett, \$7.4m; Rochester, \$23.3m.

The projected tax impact for individual residents in Acushnet is \$722 per year, based on an average single family home assessed at \$471,732.

The vote will be decided by a majority of the aggregated votes of all five communities, not by individual community votes. All communities will have to abide by the decision, whether or not their individual community supported it.

The new school will increase student population by more than 200 to 776. It will add three new programs: Plumbing, HVAC-R, and Dental Assisting.

The new building will be 270,000 square feet. The current building, built in 1975, is 104,395 sf.

At the 11/10 meeting, much of the discussion revolved around the pros

and cons of building new vs. repairing the current building. Repairing the current building will not be reimbursed by the state.

The structure needs extensive plumbing work, electrical work, and needs to be brought up to American with Disabilities Act (ADA) standards.

The current building also does not have fire suppression (sprinklers).

Repairing the current building also does not address space issues or allow the district to add new programs.

SB member Kevin Gaspar and Mr. Boucher, both pointed out, however, that repairs would not have to be done all at once. The district could schedule different repairs on different parts of the building for different years. That would allow the towns to fund their shares in smaller chunks instead of borrowing tens of millions of dollars for 20 years.

The boards also discussed specific numbers of students enrolled now and predictions for future years. The town will be assessed its share of paying the bond based on enrollment. Right now, Acushnet has the largest

# Jeff Lucas is chosen for Planning Board vacancy

The Fairhaven Planning Board met jointly with the Select Board on 11/10/25 to choose a replacement for Dianne Tomassetti, who resigned on 10/20, and then tried to rescind her resignation. She applied to fill that vacancy, along with former PB member, Rick Trapilo; and long time PB member, Jeff Lucas. Michelle Costen also applied, but then withdrew her application.

The three candidates gave opening statements and then were asked questions by SB chair, Charles Murphy, and PB chair, Jessica Fidalgo.

In his opening statement, Mr. Trapilo said he was raised to believe deeply in public service. He said he also witnessed how difficult it was to move a community forward during the 40R process. He said PB members were sometimes subjected to personal attacks and it was disheartening.

He said Ms. Tomassetti was treated with a lack of respect and said he "wholeheartedly" supported her to be reinstated, and encouraged the

board members to vote for her. He said if they allow hostility or personal attacks to determine who steps forward then we compromise the "very heart of democracy."

He did not, however, withdraw his name, and stayed to answer questions.

Mr. Lucas talked about his qualifications as a PB member for 25 years. He said he has knowledge of the bylaws and would like to think he would be open minded in how he treats people. He said his goal is to work with the current bylaws as they stand.

"When I look at a project, I don't look at who the person is," said Mr. Lucas, adding he looks at how the project affects the town.

He also said he expects people to be respectful: "It shouldn't have to be asked for."

Mr. Lucas also said he did not intend to run for the seat next year.

Ms. Tomassetti said she wanted to take a moment to speak to residents, saying the comments of her last meeting got the better of her.

She called her resignation a "knee-jerk reaction."

"My feelings were hurt, I was stressed and felt extremely bullied," she said, adding that she tendered her resignation when she felt she was under "significant pressure and negativity that seemed to compromise my reputation, integrity, both personally and as Planning Board Chair."

"For that decision, I apologize," she said.

She said she felt that continuing on the board would bring a level of positive direction and support to the town.

Ms. Tomassetti also said she had an "obligation to the people of Fairhaven to return to the Planning Board."

She promised to provide unbiased research and communicate with board members and "town entities" to ensure the accuracy of board items.

"As a cohesive board, our impact can reach beyond individuals, reshaping our community and neighborhoods," said Ms. Tomassetti.

The applicants faced three questions, about their experience with

# Millicent completes electrical, begins HVAC improvements

The Millicent Library, a 501(c)(3) nonprofit corporation independent of the Town of Fairhaven, is responsible for the maintenance and preservation of the historic, town-owned building listed on the National Register of Historic Places, at 45 Center Street, Fairhaven.

## **Electric Upgrade Completed**

Late this past summer, the Millicent Library completed a \$468,000 electrical upgrade, made possible through the support of the Fairhaven Community Preservation Committee (CPC). The project addressed numerous electrical code violations, relocated panels from egress including stairways, and replaced aging components that posed safety risks with potential fire hazards.

As part of the upgrade, the building's electrical service was expanded from 400 amps to 800 amps to support modern operations and future improvements, including the planned installation of a new central cooling and ventilation system.

Throughout February and March, crews from Levangie Electric Company of Hanover installed new electrical panels, including a main distribution panel, and ran new conduits to relocated and replaced panels. The work also included adding emergency lighting and fire alarm smoke detectors at each panel location.

To minimize disruptions to public service, the team used the April 21 holiday closure to energize the new system. During this scheduled power shutdown, workers transferred service from each panel and began safely demolishing the old ones.

The upgrade project was managed by GGD Consulting Engineers of Dartmouth.

This upgrade marks a critical step toward the library's HVAC modernization project, which will replace the aging furnace and add much-needed cooling. In recent summers, extreme heat forced the library to close several times due to unsafe and uncomfortable indoor conditions.

The Millicent Library's electrical system has come a long way since the building's original construction. In December 1891, the Fairhaven Star reported:

"The electricians and gas fitters are finishing up their work. There will be two independent circuits in the building, the four cables or feed wires of which each contain 20 copper wires. The rooms may be lighted by one of these if the other should be deranged."

Funding for this project was made possible by the Fairhaven Community Preservation Committee through the Community Preservation Act (CPA). This act serves as a crucial tool in preserving our town's open spaces, historic resources, land for recreation, and community housing.

The Millicent Library extends its sincere thanks to the Fairhaven Community Preservation Committee for its continued support and to the community for their patience and understanding during the project.

## **HVAC Schematic Design Phase Begins**

In September, the Millicent Library selected NV5 Planning & Design of Andover to complete the schematic design for a new, energy-efficient HVAC system tailored to the library's

historic building. Torrey Architecture of Boston will serve as the historic architecture consultant for the project.

Both NV5 and Torrey Architecture bring extensive experience with historic and landmark properties, including buildings listed on the National Register of Historic Places. Their past work includes the Peabody Institute (Public) Library, City of Chicopee City Hall, and the City of Melrose Memorial Hall. Other notable projects include the Lincoln (MA) Public Library, Brown University's Rhode Island Hall, the Massachusetts State House, and the Soldiers and Sailors Memorial Building in Boston.

During this schematic design phase, the team will document existing conditions through site investigations and 3D laser scanning, evaluate system options, and develop a conceptual plan that enhances comfort and energy efficiency while maintaining the building's historic integrity. The schematic design will guide the next phase of detailed engineering and construction planning.

The planned HVAC system will replace the library's aging furnace and introduce building wide cooling and fresh air for the first time. In recent summers, the library has been forced to close several times due to high indoor temperatures. These upgrades will allow for temperature and humidity control, helping protect the library's historic collections and provide a more comfortable environment for patrons and staff year-round.

The Millicent Library is grateful for the ongoing support of the Fairhaven Community Preservation Committee which is providing funding for this project.

# Meet Buddy, King of William Street

On William Street in the heart of Fairhaven's town center lives a cat who is more than just a cat — he's a legend. His name is Buddy, and if you've ever walked through the center, there's a good chance you've met him.

With a coat of glowing orange fur and a swagger in his step that can only be described as royal, Buddy has become the unofficial king of William Street. I've never been a lover of cats, I'm a dog person for sure, but this cat is different. I suggest we make it official.

Every morning, Buddy begins his rounds. Where? No one knows fully, but I've gathered enough information over the years to take an educated guess. While most cats prefer napping in quiet corners, Buddy enjoys being where the people are. Taking his slow stroll, he's easily spotted with his tail held high like a

flag of friendliness.

Neighbors call out, "Hey Buddy!" and he always responds with a slow blink or a soft head bump to a leg. Children squeal with delight when he saunters over, giving them the honor of scratching him behind the ears.

What makes Buddy special isn't just his striking orange Mane or the unmistakable strut that sets him apart from any other cat. It's his personality — easygoing, curious, and endlessly friendly.

He doesn't just exist in Fairhaven's center; he belongs to it. It's rare for a cat to earn such

probably knows more people than some officials do. Tourists have spotted him and have been known to ask about him.

Locals just smile and say, "That's Buddy. He runs this place."

In a town that bustles with history, from cobblestone buildings to ships resting in the harbor, Buddy adds his own small but vibrant chapter. He is living proof that community doesn't just come from people; it can come from one cat who loves everyone he meets. His days are filled with pats, greetings, and the occasional treat slipped to him by someone who knows he deserves it.

At the end of the day, when the sidewalks grow quiet and the shops close, Buddy finds his way back to William Street. In a large yard, under an Evergreen tree and the slight glow of the streetlamps, he sits tall. His orange fur glowing like fire in the night. For Fairhaven, he isn't just a cat. He's the heartbeat of the town center — the king of William Street, who rules not with power, but with love.

# Recipe of the Week

## Lamb Stew

1 Tbsp. vegetable oil  
2 lb. lamb shoulder roast, cubed into 1" pieces  
1 onion, chopped  
2 carrots, peeled & cut into rounds  
2 stalks celery, chopped  
Kosher salt  
Freshly ground black pepper  
3 cloves garlic, minced  
1/4 cup tomato paste  
1 tsp. ground cumin  
1 tsp. smoked paprika  
6 cups low-sodium beef broth  
1 cup red wine  
1 Tbsp. Worcestershire sauce  
3 sprigs fresh rosemary  
2 bay leaves  
2 lb. baby potatoes, halved  
2 tsp. cornstarch, optional  
2 tsp. cold water, optional  
1/4 cup freshly chopped parsley, for garnish

In a large dutch oven or pot over medium-high heat, heat oil. Add lamb and cook on all sides until seared, 10 minutes, working in batches if necessary. Transfer to a plate.

In the same pot, cook onion, carrots, and celery until soft, 5 minutes. Season with salt and pepper. Add garlic, tomato paste, cumin, and paprika and cook until garlic is fragrant and tomato paste has darkened, 2 minutes.

Add lamb back to dutch oven then add broth, wine, Worcestershire sauce, rosemary, and bay leaves.

Bring to a boil then reduce heat to a simmer. Season with salt and pepper. Cover and let simmer until lamb is tender, 30 minutes.

Add potatoes and simmer, covered, until potatoes are tender and stew has thickened, 30 minutes. (If potatoes are tender but stew is not as thick as desired, whisk cornstarch with 2 teaspoons cold water in a small bowl until dissolved, then add to stew, bring to a boil, and stir until thickened, about 1 minute.)

Remove bay leaves and rosemary and garnish with parsley before serving.

# Fairhaven Town Mtg to face spending articles, bylaw change

Fairhaven Town Meeting members will face seven articles at a Special TM on Wednesday, 11/19/25.

Articles include spending items totalling just under \$1 million, and a bylaws change that would significantly increase fees at the Animal Shelter. (See related article in 10/16/25 issue.)

The largest spending item is Article 6, asking for for \$500,000 in borrowing for water main replacement on Glenhaven Avenue. It will require a 2/3 vote for borrowing.

The next largest item is article 3 asking for \$297,803 to be transferred from the Sewer Enterprise Fund to

the Sewer Nitrogen Plant Article 15A from 2022.

Article 4 requests a transfer of \$40,000 from Free Cash to go into General Fund Reserves, and \$30,000 into the Preventative Maintenance Article 10-5 of the May 3, 2025 TM. The funds are for the Town Hall East Retaining wall emergency repairs. The Finance Committee had to use reserve funds for the project because the scope of the project expanded due to unexpected complications.

Article 5 requests \$50,000 to hire a consultant for the Public Safety Complex.

Article 2 requests \$82,185 for labor contracts, but the number has not been finalized.

Article 7 would amend the bylaws to increase fees at the animal shelter.

If passed, the boarding fee would go from \$25/day to \$50/day; adoption fees for cats would go from \$200 to \$300, and from \$300 to \$600 for dogs.

Special Town Meeting will be held at Hastings Middle School, 30 School Street, Fairhaven, on Wednesday, 11/19, at 7 p.m. Precinct meetings will be on Thursday, 11/13, at 6:30 p.m. at HMS, followed by a Special Town Meeting Preview.

very afraid. As a parent, I had spent my efforts keeping my children out of danger, and here he was, walking right into it."

Ms. Mello gave some examples of her son's sensitivity.

"I couldn't imagine the horrors he would be witness to and I desperately wanted to shield him from that," she said.

But he was over 18 and had signed a contract.

Ms Mello recounted his first few posts and how they corresponded while he was in basic training and became closer.

Then he went to Iraq, to Camp Cropper, where Saddam Hussein had

been held, and where high level detainees were still being held.

"Dan earned more commendations while there but that experience fundamentally changed him," said Ms. Mello. "I will never know the extent of the trauma that he experienced but it profoundly affected him. All my worst fears were realized."

Ms. Mello said we often hear about bravery and heroism displayed by military service members for the greater good of our nation. But there are battles that continue long after the uniform comes off

Her son served with courage and pride, leaving home ready to make a difference. But the realities of war have left a mark that "words cannot fully describe."

"It is struggle that no one can truly understand unless they have lived it," she said.

PTSD is often a silent battle that affects friends, families and communities.

"And while the wounds may not be seen, they are no less real," she said. "As a parent,

watching my son grapple with PTSD has been heart-wrenching."

Recovery is a long and difficult journey, she said, requiring patience, support and compassion.

"It's easy to forget that the scars of war don't just fade away, and that veterans need more than just thanks," said Ms. Mello. "They need real support."

She thanked the veterans there for their service, saying their sacrifice has not gone unnoticed.

"You are seen. You are valued. And we owe it to you to make sure you are not forgotten," she said.

To all those fighting PTSD, she said they are not defined by their trauma.

"You are defined by your courage, your resilience, and your willingness to keep moving forward, no matter how hard the path may be," said Ms. Mello. "We will walk this journey together."

The ceremony also included the reading of the governor's proclamation by Select Board chairperson, Charles Murphy; an opening and closing prayer; selections by the Fairhaven High School band; bagpipes by Bruce Webb; and remarks from state rep. Mark Sylvia. The public was invited to the senior center for refreshments after the ceremony.

# Fairhaven honors veterans with parade, ceremony

During the first cold snap of the season, at about 32°, Fairhaven celebrated Veterans Day on 11/11/25 with a parade down Main Street. People bundled up to line the street and attend the ceremony at the high school where they raised the Big Flag and listened to some speechmaking and music.

Mackenzie hung out with her daughters, Mae and Roslyn, eating a donut while waiting for the parade to reach the high school. Mackenzie said her father was Peter Reid, well known for his work at Riverside Cemetery.

"It's the first time without him," said Mackenzie. "So it's a little sad."

But, she admitted, the donut helped a little.

Guest speaker, SFC Bill Kligel, a 30-year veteran of combined service in the US Navy and Army, gave a little background on himself and his family. Then he gave the background of where all veterans began, noting it is the 250th birthday of the US Army, established on June 14, 1775.

The oldest branch, now the National Guard, started on December 13, 1636, as the Massachusetts Militiamen, making it 389 years old. In the 1930's, the Army reserves formed and the Guard, reserves and regular Army became the "All One Army."

The newest branch, the US Space Force, was formed on December 20, 2019 as the sixth armed service. Space force was originally referred to

as Air Force's "Star Wars" on March 23, 1983, established by President Reagan. Other branches he noted are: Marines, 11/10/1775; Navy, 10/13/1775; Air Force, 9/18/1947; Coast Guard, 8/4/1790.

"I took the time to list all our branches so we may remember where our veterans come from and how long we have been around," said SFC Kligel. "The original term 'veterans' was legally determined by the Veteran's Administration, or VA, for purpose of benefit, and did not include National Guard status until 1980."

He claims, he said that a veteran is a person who guarantees our future



family," he said. "One who knows the torment we seldom speak of and our struggle to never forget the bond that no one or any enemy will ever break."

He said veterans put trust in each other and brings true love to our flat and our country.

"And when we call them they will always be there to defend freedom," he said. "We do this freely for all of you."

Select Board member Natalie Mello also spoke, sharing with the world the struggles her son has faced after being deployed to Iraq.

Ms. Mello recounted some of his childhood, his dreams and activities. Then, he told her "casually," while she was driving, that he had enlisted in the Army.

"I almost drove off the road," said Ms. Mello. "I was stunned and very,

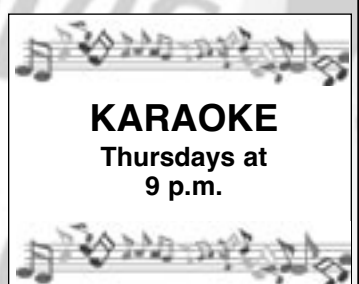

share at 35%. Estimates for future enrollment are 160 to 200.

On 11/10, Mr. Boucher said the financial impact on the town's budget is troublesome. He said they are likely looking at a Proposition 2 1/2 override. He noted that the town also faces increases in health insurance and pension costs.

It puts too much on the backs of residents, said Mr. Boucher.

Mr. Gaspar said that if the district decided on repairs, the town would not necessarily have to go for an override. They could go for a debt exclusion for a smaller amount, around \$4 million.

Mr. Boucher noted that the schools are already 60% of the town's budget.

"Our kids are nomads," said SB member David Wojnar. "They don't have a home."

He said it might be time for Acushnet to talk about how the town approaches 9-12 education, and this project might be the catalyst.

Acushnet students in high school attend Fairhaven HS or Old Colony. He said they are lucky to have them. But the contract with Fairhaven is up

for renewal, and Acushnet has been looking at other high schools.

Parents with eighth-graders have been calling, he said, because they have no idea where their children will be going next year.

Board members also discussed the consequences of waiting, with rising costs every making the building even more expensive.

Aaron Polansky, Superintendent-Director at OC, said that OC is not just a place where kids get an education. It is a service based organization that gives back to each community. He listed a number of projects built by students in each member community.

He cautioned against putting Band-aids on a 50 year old building.

"Years from now I can't even imagine what this will cost," said Mr. Polansky.

Resident Rod Gomes said he was "staggered" when he saw the numbers. But he also said it would be fiscally irresponsible to renovate the existing building that was built to last 30 years and is now 50 years old.

He also noted that building the new school allows the students to

stay in the old building during construction. If they remodel, the students can't use it.

"We have no other school to send them to," he said.

Mr. Gaspar said he would not say which way the town will vote, and he said he would not tell people how to vote. It is up to the individual, based on what they can afford, he said.

technical documents and site plans, and their ability to conduct site visits; how they would make sure the public is considered for projects, especially those facing strong community opposition; and how they would approach conflicts of interest and their own bias.

At the end of the questioning, PB member, Patrick Carr, said SB member, Andrew Romano (who beat Mr. Carr in the election for the SB seat in 2024), should recuse himself from the vote because Romano and Lucas are both members of the North Fairhaven Improvement Association.

Mr. Carr questioned why Mr. Romano was not stepping aside, noting that he has said in the past that any appearance of a Conflict of Interest should be reason enough for a board member to recuse himself. Mr. Carr cited several instances, with dates, quoting Mr. Romano.

Mr. Romano was ready, saying he filed the disclosure because he had a feeling the issue would come up. He also said he checked with the state Ethics Commission. He has no

financial relationship with Mr. Lucas, he said, so there is no COI.

He went through each of the cited cases and explained his position.

In the end the board took a vote for Ms. Tomassetti first, with SB member Keith Silvia nominating her, seconded by SB member Andrew Saunders.

The vote ended in a tie. PB is an eight-member board, minus Ms. Tomassetti, leaving seven to vote; SB is a five member board, 12 total.

A tie vote means the motion dies.

"Yes" votes for Ms. Tomassetti were SB members, Mr. Saunders, Mr. Silvia, and Mr. Murphy; and PB members, Mr. Carr, Sharon Simmons, Ruy DaSilva.

The second vote was for Mr. Lucas, nominated by SB member Natalie Mello and seconded by Mr. Romano, which passed 7-5, with "yes" votes for Mr. Lucas being SB members, Mr. Murphy, Mr. Romano, and Ms. Mello; and PB members, Miles Grant, Sean Powers, Kevin Grant, Jessica Fidalgo.

Mr. Lucas and Ms. Tomassetti shook hands after the vote.

In another matter, the SB tabled an

item for an update on the zoning bylaw project. Town Administrator, Keith Hickey, was not at the meeting, so the board decided to wait until he could give the update.

The board also approved a change to the flag/banner policy, and the use of town hall process.

The Flag/Banner policy will now require a 30 day notice for a request to hang a flag or banner on town property, instead of 60 days.

A requests for use of town hall will also require 30 days instead of 60 days. The policy also changes the fee to \$150/hour for all groups, except Town government groups.

In other business the board:

- Voted to reclassify the Treasurer/Collector position to Grade 20 from Grade 19, to be competitive with other municipalities competing for talent. The current Treasurer/Collector has announced her retirement.
- Appointed Timothy Cox to the Public Safety Complex Committee, replacing the Planning Director, who resigned.

## From our readers

### **Neighbors Oppose Hiller/Timothy Project, Appeal Building Permits**

#### **Congratulations Robbie Roderiques**

After years of trying to get your 16 home subdivision through the Planning Board, being denied every time on the basis it was not a good fit at that scale for the location, you chose to sue the Town.

When that failed (at every level of the court system) you created a new LLC and submitted the same 16 home subdivision plans then sat quietly, waiting for the Town to slip up and not act on them, knowing full well that if no action was taken you could bypass due process and get your way. You intentionally deceived the Town Government and an entire neighborhood in the Town in which you live.

Congratulations on your continued stiff-arming of Town Government as you build new homes on lots that do not match those designated on the Building Permits, all while holding the Town at bay with regard to the surety bond the Town Bylaws require. This places the Town at financial risk. On October 15th, the day after the Planning Board meeting, you received a request for a site visit by the Planning Board. One month later, you have yet to allow that to happen. How's that for cooperation from a Town based business?

#### **Congratulations Pat Carr**

For a period of at least 6 months, while holding the positions of Chair, Vice Chair, and member of the Planning Board, you knew about the plans submitted by Windmill Acres, LLC and you were fully aware that if the Town did not take action for 155 days, "Constructive Approval" would be granted to the applicant, bypassing the entire Planning Process. Every single one of those 155 days was a new opportunity for you to do the right thing, and make it known to your fellow Board members that those plans had been submitted — yet you kept silent. We have learned that you, Ms. Tomasetti and Select Board member, Keith Silvia, called for a meeting with the Town Administrator trying to extract a pound of flesh from the now resigned Planning Director, but let's be real... in your role, YOU had the responsibility to act and failed to do so.

The Mission Statement of the Planning Board calls for the Board to pay particular attention to "conditions affecting public welfare and safety related to land use and development... with special attention to the proper housing of Town residents". Are you proud of the way you served your community on this one, leaving the Town with no say on a project that has left abutters with flooded yards, no tree buffer between them and the wastewater treatment plant and wind turbines, etc.?

A group of abutters has filed an Administrative Appeal to the Zoning Board of Appeals (ZBA)\* claiming that the Building Permits for five homes should never have been issued for a host of reasons. That meeting will take place on December 4th. Given your history with this subdivision project, will you do the right thing and recuse yourself from deliberations on that agenda item?

#### **Congratulations Cathy Melanson**

In your role as Chair of the Planning Board before the last election you could and should have made this all known to the Planning Board. Even after the election, as an ordinary citizen, if you had any regard for your community, your Town Government, and due process, you could have acted. You had the same 155 days that Mr. Carr did to notify Planning Board members about this proposed subdivision that you too knew would go to "constructive approval" if not acted on. Like Mr. Carr, your lips were sealed. Furthermore, you are the only one of 18 people who has not complied with a records request made on September 24th.

Unfortunately, the inaction of just a few people on a housing development worth on the order of \$8-12M will permanently alter a neighborhood to an extent that was not necessary (or desired by the Planning Board). We deserve answers, transparency, accountability, and assurances this will not happen again. On October 23rd, we called for the Select Board to place an item on their next meeting agenda (October 28th) to consider calling for an investigation. Two Select Board meetings have passed without that agenda item. We will not stop asking. We hope others in the community will support us by advocating for openness, transparency

and accountability from our Elected Officials and Town Government with an eye toward ensuring something like this will never happen again.

Thank you for the opportunity to testify on my strong support for the Climate Superfund bills, H.1014 and S.588. These bills will help Massachusetts communities prepare for the damaging climate change effects Big Fossil Fuel companies predicted 50 years ago.

The Southcoast includes 11 communities along Buzzards Bay, with a total population of over 320,000. The Port of New Bedford, the largest \$\$ grossing fishery in the US, and Dartmouth's UMASS campus are both located here. In 2023, 52M visitors enjoyed our beaches, marinas, nature preserves and museums. There's a lot going on here we need to protect.

Fairhaven is a purple town, but

The country is in the throes of a shutdown and instead of concentrating his attention to remedy this calamity he provokes Venezuela,

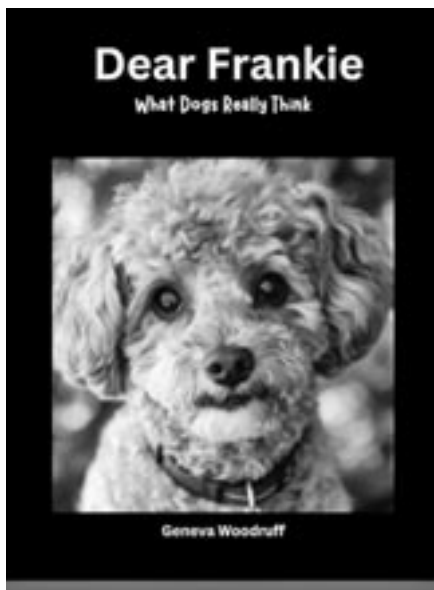
